### A BILL FOR AN ACT

PROPOSING AN AMENDMENT TO ARTICLE III, SECTION 4, OF THE CONSTITUTION OF THE STATE OF HAWAII TO ESTABLISH TERM LIMITS FOR LEGISLATORS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that, according to a 2023 2 Pew Research study, a vast majority of Americans support term 3 limits for legislators. Concern regarding career politicians 4 and the recent issues of public corruption have many residents 5 worried about the status of legislative term limits. While the 6 residents have often called for legislative reform, one measure 7 that has consistently not been adopted is term limits for 8 legislators.

9 The legislature also finds that at least fifteen states 10 have limits on the number of years a person may serve as a 11 member of the legislature during the person's lifetime, which 12 range from eight to twelve years. Given the legislature's part-13 time nature and the differences between the house of 14 representatives and the senate, the twelve-year term limit 15 between the two chambers would be most equitable.

The accumulation of time 4 served in the legislature shall begin on or after the general 5 election of 2024. The term of a member of the legislature shall 6 begin on the day of the general election at which elected or if 7 elected at a primary election, on the day of the general election immediately following the primary election at which 8 9 elected. For a member of the house of representatives, the term 10 shall end on the day of the general election immediately 11 following the day the member's term commences. For a member of 12 the senate, the term shall end on the day of the second general 13 election immediately following the day the member's term 14 commences." 15 SECTION 3. The question to be printed on the ballot shall
