### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 201H-202, Hawaii Revised Statutes, is
 amended by amending subsection (e) to read as follows:

"(e) Moneys available in the fund shall be used for the
purpose of providing, in whole or in part, loans or grants for
rental housing projects in the following order of priority:

6 (1) Projects that are owned by the State, any county, or
7 any organization obliged to use all financial surplus
8 generated by the project to construct more housing or
9 rehabilitate or manage housing;

10  $\left[\frac{1}{1}\right]$  (2) Projects or units in projects that are allocated 11 low-income housing credits pursuant to the state 12 housing credit ceiling under section 42(h) of the 13 Internal Revenue Code of 1986, as amended, or projects 14 or units in projects that are funded by programs of 15 the United States Department of Housing and Urban 16 Development and United States Department of 17 Agriculture Rural Development wherein:
