A BILL FOR AN ACT

RELATING TO THE WORKS OF ART SPECIAL FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. The legislature finds that art feeds the human spirit and offers priceless value. Art inspires, educates, and challenges individuals to think differently, while making the
- 4 world a more beautiful and interesting place. The legislature
- 5 further finds that Hawaii was the first state in the nation to
- 6 adopt a percent-for-art law, which designated one per cent of
- 7 construction costs of new buildings for the acquisition of works
- $oldsymbol{8}$ of art. The purpose of the law was to beautify state buildings
- $oldsymbol{9}$ and increase public access to the arts. The legislature
- 10 expanded on this effort by enacting Act 389, Session Laws of
- 11 Hawaii 1989, which created the works of art special fund. The
- 12 legislature finds that this program has been a success, with
- 13 works of art enhancing the physical environment of state
- 14 buildings and providing educational visual arts opportunities to
- 15 the public through the art in public places program.
- 16 The works of art special fund currently applies to capital
- 17 improvement appropriations that are designated for the



- 1 construction or renovation of state buildings. While the
- 2 construction or renovation of state buildings requires that they
- 3 be furnished with works of art acquired through the special
- 4 fund, this requirement is not necessary for the construction of
- 5 site work, including but not limited to the construction of
- 6 roads, bridges, surface parking, and athletic fields and courts.
- 7 The legislature notes that removing the redundancy of applying
- 8 the special fund to the construction of site work would have no
- 9 adverse effects on the art in public places program, as the
- 10 State currently possesses a surplus of artwork in storage for
- 11 future use.
- Accordingly, the purpose of this Act is to amend the works
- of art special fund's one per cent transfer requirement to
- 14 exclude capital improvement appropriations designated for the
- 15 construction of site work.
- 16 SECTION 2. Section 103-8.5, Hawaii Revised Statutes, is
- 17 amended by amending subsection (a) to read as follows:
- "(a) There is created a works of art special fund, into
- 19 which shall be transferred one per cent of all state fund
- 20 appropriations for capital improvements designated for the
- 21 construction cost element; provided that this transfer shall

1	apply onl	y to capital improvement appropriations that are
2	designated for the construction or renovation of state	
3	buildings	. The one per cent transfer requirement shall not
4	apply to	[appropriations]:
5	(1)	Appropriations from the passenger facility charge
6		special fund established by section 261-5.5 and the
7		rental motor vehicle customer facility charge special
8		fund established under section 261-5.6[\div]; and
9	(2)	Appropriations that limit work strictly to
10		construction of site work such as roads, waterworks,
11		bridges, airfields, walls, canals, surface parking,
12		utilities, piers, landscaping, athletic fields, and
13		play courts."
