## A BILL FOR AN ACT

RELATING TO THE WORKS OF ART SPECIAL FUND.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that art feeds the human 2 spirit and offers priceless value. Art inspires, educates, and 3 challenges individuals to think differently, while making the 4 world a more beautiful and interesting place. The legislature 5 further finds that Hawaii was the first state in the nation to 6 adopt a percent-for-art law, which designated one per cent of 7 construction costs of new buildings for the acquisition of works 8 of art through Act 298, Session Laws of Hawaii 1967 (ACT 298). 9 The purpose of the law was to beautify state buildings and 10 increase public access to the arts. Act 298 statutorily 11 established that "the original construction of any state 12 building shall include ... an amount of one percent of the 13 appropriation for the acquisition of works of art which may be 14 an integral part of the structure ... " This original statute 15 was carefully crafted to maintain fiscal integrity in the use of 16 long-term capital funding.

1	The legislature expanded on this effort by enacting Act		
2	389, Session Laws of Hawaii 1989, which created the works of art		
3	special fund. The legislature finds that this program has been		
4	a success, with works of art enhancing the physical environment		
5	of state buildings and providing educational visual arts		
6	opportunities to the public through the art in public places		
7	program. Additionally, the State currently possesses a surplus		
8	of artwork in storage for current and future uses.		
9	More recent efforts have focused on the expansion of		
10	programs to include performing arts and other initiatives that		
11	would enhance an array of art programming across the State.		
12	Even as programs evolve and change over the years, it is		
13	imperative that sound financial management be exercised to		
14	ensure the stability of factors that may affect the State's		
15	creditworthiness.		
16	Accordingly, the purpose of this Act is to:		
17	(1) Specify that the works of art special fund's one per		
18	cent transfer requirement shall apply only to capital		
19	improvement appropriations for the original		
20	construction of state buildings; and

- (2) Appropriate funds for performing arts and other
   initiatives in schools.
- 3 SECTION 2. Section 103-8.5, Hawaii Revised Statutes, is
- 4 amended by amending subsection (a) to read as follows:
- 5 "(a) There is created a works of art special fund, into
- 6 which shall be transferred one per cent of all state fund
- 7 appropriations for capital improvements designated for the
- 8 original construction [cost element; provided that this transfer
- 9 shall apply only to capital improvement appropriations that are
- 10 designated for the construction or renovation] of state
- 11 buildings. The one per cent transfer requirement shall not
- 12 apply to appropriations from the passenger facility charge
- 13 special fund established by section 261-5.5 and the rental motor
- 14 vehicle customer facility charge special fund established under
- 15 section 261-5.6."
- 16 SECTION 3. There is appropriated out of the general
- 17 revenues of the State of Hawaii the sum of \$ or so

- 19 performing arts initiatives.
- The sum appropriated shall be expended by the state
- 21 foundation on culture and the arts for the purposes of this Act.
