A BILL FOR AN ACT

RELATING TO EDUCATION FOR MENTAL HEALTH PROFESSIONALS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that there is a severe

2 shortage of mental health service providers in the State. This

3 shortage is due to a lack of appropriately educated individuals

4 and high rates of turnover in the field, which is exacerbated by

5 compassion fatigue, burnout, and inadequate preparation for the

6 provision of mental health services. The legislature therefore

7 finds that the mental health provider shortage in the State is a

8 matter of statewide concern.

9 The legislature further finds that the university of Hawaii

Windward community college, in collaboration with the Hawaii

11 state hospital, has developed an entry-level mental health

12 technician certificate of competence program. Furthermore, they

have developed a stackable degree program that builds on this

certificate with another seven courses to earn a cetificate of

15 achievement. All these credits can then be applied toward an

16 associate of arts or a bachelor of arts degree in pathways such

17 as social work and psychology.

- 1 The legislature additionally finds that the coursework for
- 2 these programs addresses the immediate and critical workforce
- 3 needs of preparing potential employees and upskilling existing
- 4 employees for the Hawaii state hospital. The coursework also
- 5 has the potential to do the same for employees working in entry-
- 6 level mental health jobs at organizations across the State in
- 7 collaboration with their local community college.
- 8 Furthermore, Windward community college offers a trauma
- 9 informed care pathway for the Honolulu police department and
- 10 adult corrections officers. This curriculum is also a stackable
- 11 degree program with credits that can be applied toward a
- 12 certificate of achievement or degrees, such as an associate of
- 13 arts or bachelor of arts.
- 14 These programs help to grow the State's overall capacity to
- 15 address the mental health challenges and needs of Hawaii's
- 16 residents.
- 17 The asynchronous online courses can be offered to
- 18 professionals working with the mentally ill and students across
- 19 the State, with Windward community college coordinating with
- 20 other community colleges in the university of Hawaii system.
- 21 For these programs to be offered statewide, additional resources

1 are needed to provide for key personnel and establish a 2 scholarship program to increase access for individuals who are 3 unemployed, underemployed, low-wage earners, or otherwise 4 interested in pursuing a career pathway in mental health. 5 The purpose of this Act is to appropriate funds to the 6 university of Hawaii Windward community college for the 7 establishment of positions to support the statewide expansion of 8 the university of Hawaii Windward community college's mental 9 health-related programs. 10 SECTION 2. There is appropriated out of the general 11 revenues of the State of Hawaii the sum of \$ or so 12 much thereof as may be necessary for fiscal year 2024-2025 to 13 support the statewide expansion of the university of Hawaii 14 Windward community college's mental health-related programs, to 15 be expended as follows: 16 (1) for the establishment of one temporary 17 full—time equivalent (1.0 FTE) faculty instructor 18 position to develop and administer curriculum; 19 (2) for the establishment of one temporary 20 full-time equivalent (1.0 FTE) faculty outreach

1	and carry out any other necessary administrative
2	tasks; and
3	(3) \$ for the establishment of a scholarship
4	program, the granting of scholarships, and other
5	necessary administrative costs.
6	The sum appropriated shall be expended by the university of
7	Hawaii for the purposes of this Act.
8	SECTION 3. In accordance with section 9 of article VII of
9	the Hawaii State Constitution and sections 37-91 and 37-93,
10	Hawaii Revised Statutes, the legislature has determined that the
11	appropriations contained in H.B. No. , will cause the state
12	general fund expenditure ceiling for fiscal year 2024-2025 to be
13	exceeded by \$ or per cent. In addition, the
14	appropriation contained in this Act will cause the general fund
15	expenditure ceiling for fiscal year 2024-2025 to be further
16	exceeded by \$ or per cent. The combined total
17	amount of general fund appropriations contained in only these
18	two Acts will cause the state general fund expenditure ceiling
19	for fiscal year 2024-2025 to be exceeded by
20	\$ or per cent. The reasons for exceeding the
21	general fund expenditure ceiling are that:

1	(1)	The appropriation made in this Act is necessary to
2		serve the public interest; and
3	(2)	The appropriation made in this Act meets the needs
4		addressed by this Act.
5	SECT	ION 4. This Act shall take effect on July 1. 3000.
