BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 802-5, Hawaii Revised Statutes, is
 amended by amending subsection (b) to read as follows:

3 "(b) The court shall determine the amount of reasonable
4 compensation to appointed counsel, based on the rate of [\$90]

SECTION 2. In accordance with section 9 of article VII, of 4 5 the Constitution of the State of Hawaii and sections 37-91 and 37-93, Hawaii Revised Statutes, the legislature has determined 6 7 that the appropriation contained in this Act will cause the 8 state general fund expenditure ceiling for fiscal year 2024-2025 9 to be exceeded by \$, or per cent. The reasons 10 for exceeding the general fund expenditure ceiling are that the 11 appropriation made in this Act is necessary to serve the public 12 interest and to meet the needs provided for by this Act. 13 SECTION 3. There is appropriated out of the general 14 revenues of the State of Hawaii the sum of \$ or so 15 much thereof as may be necessary for fiscal year 2024-2025 to 16 carry out the purposes of this Act. 17 The sum appropriated shall be expended by the department of budget and finance for the purposes of this Act. 18
