# A BILL FOR AN ACT

MAKING AN EMERGENCY APPROPRIATION TO THE DEPARTMENT OF HEALTH TO IMPLEMENT QUALITY IMPROVEMENT RECOMMENDATIONS FOR THE HAWAII STATE HOSPITAL.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. This Act is recommended by the governor for
immediate passage in accordance with article VII, section 9, of
the Hawaii State Constitution.

4 SECTION 2. The legislature finds that the Hawaii state 5 hospital is the only publicly funded state psychiatric hospital in the State. The hospital is organized within the department 6 7 of health adult mental health division, and provides adult 8 inpatient psychiatric services. It is accredited by The Joint 9 Commission, most recently in December 2021 for thirty-six 10 months, and is licensed as a health care facility by the 11 department of health's office of health care assurance.

12 The department contracted with a consultant in 2023 to 13 evaluate hospital operations in response to increasing demand 14 for secure psychiatric services. The consultant's report was 15 submitted in early 2024 and makes recommendations for 16 effectively accommodating the rising influx of patients while
