A BILL FOR AN ACT

RELATING TO CHILD CARE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 346, Hawaii Revised Statutes, is
- 2 amended by adding a new section to part VIII to be appropriately
- 3 designated and to read as follows:
- 4 "§346- Demonstration projects; requirements;
- 5 modifications. (a) A child care facility may establish a
- 6 demonstration project for a specific purpose, or set of
- 7 purposes, upon receiving written approval from the department.
- 8 (b) The child care facility shall submit a written
- 9 proposal to the department indicating the following:
- 10 (1) Purpose of the project;
- 11 (2) Description of the project;
- 12 (3) Length of the project;
- (4) Specific child care rules that shall be exempted by
- the project; and
- 15 <u>(5)</u> <u>Justification for the proposed exemptions.</u>
- (c) The persons responsible for the project, or their
- 17 designee, shall appear in person to discuss the proposal with

1	the depar	tment, or the department's designee, upon request by
2	the depar	tment.
3	(d)	A demonstration project that has been approved in
4	writing b	y the department shall include, at the time of the
5	project's	approval:
6	(1)	The words "licensed demonstration project" in the name
7		or description; and
8	(2)	Proof that the project is, at all times, in compliance
9		with the child care rules, except as specifically
10		exempted or modified in the department's written
11		approval; and
12	<u>(e)</u>	Within the last quarter of the time specified for the
13	demonstra	tion project, the child care facility shall submit a
14	written r	eport to the department, which shall include:
15	(1)	Developments, findings, recommendations, and
16		suggestions for further study; and
17	(2)	Any proposed recommendations for changing or modifying
18		child care rules under the demonstration project,
19		along with justifications for the change or
20		modification.
