SECTION 1. Section 291J-5, Hawaii Revised Statutes, is

RELATING TO PHOTO RED LIGHT IMAGING DETECTOR SYSTEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

Section 291J-6, Hawaii Revised Statutes, is amended by amending subsection (a) to read as follows: 4 "(a) Notwithstanding any law to the contrary, and except 5 for the time period allowed pursuant to section 291J-4(e), 6 7 beginning January 1, 2021, whenever any motor vehicle is determined, by means of a photo red light imaging detector 8 system, to have disregarded a steady red signal in violation of 9 10 section 291C-32(c), the State's or county's third party contractor shall cause a summons or citation, as described in 11 this section, to be sent by first class mail to the registered 12 owner of the motor vehicle. The summons or citation shall be 13 14 mailed to the registered owner's address on record at the 15 vehicle licensing division and [postmarked] submitted to the post office within ten calendar days after the date of the 16 17 incident. The State, the county, or the State's or county's 18 third party contractor shall implement a process to record the 19 date on which the summons or citation was submitted to the post 20 office, and the record shall be prima facie evidence of the date 21 the summons or citation was submitted to the post office. - 1 the end of the ten calendar day period falls on a Saturday,
- 2 Sunday, or holiday, then the ending period shall run until the
- 3 end of the next day that is not a Saturday, Sunday, or holiday."
- 4 SECTION 3. This Act does not affect rights and duties that
- 5 matured, penalties that were incurred, and proceedings that were
- 6 begun before its effective date.
- 7 SECTION 4. Statutory material to be repealed is bracketed
- 8 and stricken. New statutory material is underscored.
- 9 SECTION 5. This Act shall take effect upon its approval.

Photo Red Light Imaging; Highway Safety; Traffic Violations; Transportation

Description:

Provides that any photo red light imaging detector system's clear and unobstructed recorded image of a motor vehicle license plate shall be prima facie evidence that the motor vehicle to which the license plate is attached is the motor vehicle for which the license plate was issued. Requires the State, the county, or the State's or county's third party contractor to implement a process to record the date on which the summons or citation was submitted to the post office, which shall be prima facie evidence of the date the summons or citation was submitted to the post office.
