### A BILL FOR AN ACT

RELATING TO INVASIVE SPECIES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Chapter 150A, Hawaii Revised Statutes, is
2	amended b	y adding a new section to be appropriately designated
3	and to re	ad as follows:
4	" <u>§15</u>	0A- Invasive species inspection placard program.
5	(a) The	department of agriculture shall establish and implement
6	<u>an invasi</u>	ve species inspection placard program to:
7	(1)	Enhance the control, removal, and eradication of
8		invasive species on the premises of an agricultural
9		producer; and
10	(2)	Inform the public of the most recent invasive species
11		inspection results for agricultural producers.
12	(b)	In establishing the invasive species inspection
13	placard p	rogram, the department shall develop a system to:
14	(1)	Conduct inspections annually or in response to a
15		complaint on the premises of an agricultural producer
16		to determine if any invasive species are on the
17		premises of the agricultural producer; and

1	(2) If any invasive species are found, allow for the
2	removal or eradication of any discovered invasive
3	species by the agricultural producer within a time
4	period as determined by the department.
5	(c) The department shall issue to the agricultural
6	producer a corresponding color coded placard indicating the
7	compliance status of the agricultural producer after completion
8	of the inspection or after the allowed time period to remove or
9	eradicate the discovered invasive species.
10	(d) The department shall post the results of all invasive
11	species inspections conducted pursuant to this section on the
12	department's website and update the results upon completion of
13	each inspection.
14	(e) The department shall adopt rules pursuant to chapter
15	91 necessary for the implementation of this section.
16	(f) As used in this section:
17	"Agricultural producer" means a farmer, cooperative
18	association, or landowner who derives at least fifty per cent of
19	its gross income from agricultural activities conducted within
20	the State.



1	"Invasive species" means any animal, insect, disease agent,
2	or other organism in any stage of development that is
3	detrimental or potentially harmful to agriculture."
4	SECTION 2. New statutory material is underscored.
5	SECTION 3. This Act shall take effect upon its approval.
