A BILL FOR AN ACT

RELATING TO BEACH PARK RESTORATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Kahalu'u bay on
- 2 Hawai'i island is located 4.5 miles south of the town of Kailua-
- 3 Kona and is situated in a major resort area. While the State
- 4 has jurisdiction over the bay's shoreline until the high water
- 5 mark, the county of Hawai'i owns and operates the Kahalu'u beach
- 6 park facility, which is heavily utilized by both residents and
- 7 tourists, recording over four hundred thousand visitors
- 8 annually. The county of Hawai'i uses an innovative public-
- 9 private partnership with the Kohala Center's Kahalu'u Bay
- 10 Education Center to provide daily stewardship management
- 11 intended to promote long-term preservation.
- 12 The legislature further finds that in 2022, the county of
- 13 Hawai'i and United States Army Corps of Engineers, under section
- 14 206 of the Water Resources Development Act of 1996, requested
- 15 federal assistance for aquatic ecosystem restoration due to
- 16 impacts of climate change, overuse, trampling of live coral and

- 1 other marine life, and sunscreen chemicals degrading the Kahalu'u
- 2 bay marine area, a crucial spawning area for cauliflower and
- 3 other corals. The legislature further finds that funding can
- 4 supplement interagency efforts that require sea-level rise
- 5 studies and reports to preserve vulnerable sections of the
- 6 State's coastline, including at Kahalu'u bay.
- 7 Kahalu'u bay has historically been regarded as a sacred
- 8 place to Native Hawaiians, adorned with heiau, fishponds, and
- 9 barrier rock walls that provide good fishing conditions for
- 10 hunter-gatherers in the area. Due to its historic nature and
- 11 popularity among visitors, there have been recent efforts by the
- 12 county of Hawai'i, in partnership with the Kahalu'u Bay Education
- 13 Center, to preserve the beach park for future generations
- 14 through the promotion of reef-friendly practices. The
- 15 legislature finds that due to the tireless advocacy of the
- 16 education center, Kahalu'u bay was designated as a Mission Blue
- 17 Hope Spot in 2022, demonstrating how smaller bays can integrate
- 18 networks powered by modern technology with traditional knowledge
- 19 to care for these places. In 2023, the Kahalu'u Bay Education
- 20 Center further illustrated its reliability as a governmental
- 21 partner through its visitor parking fee pilot project in

2 of-state visitors to pay a parking fee in four-hour intervals from 7:00 a.m. through 7:00 p.m. daily with revenues directed 3 4 towards ongoing protection, stewardship, and restoration of the 5 natural and cultural resources at Kahalu'u beach park. 6 The legislature also finds that the Kahalu'u Bay Education Center's efforts have greatly benefited Kahalu'u beach's marine 7 8 and coastal ecosystem. However, they do not shield the beach 9 park from the impacts of global warming. Thus, an interagency 10 Kahalu'u bay restoration working group, comprised of state and county officials and community leaders, was convened and has 11 12 been planning for the restoration of Kahalu'u beach park. 13 legislature believes that the group's findings warrant a 14 prioritization of Hawai'i island's overall coastal planning, as
