A BILL FOR AN ACT

RELATING TO THE DEATH CARE INDUSTRY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 469, Hawaii Revised Statutes, is
2	amended by adding a new part to be appropriately designated and
3	to read as follows:
4	"PART . FUNERAL DIRECTORS AND CEMETERY SALESPERSONS
5	§469- Definitions. As used in this part:
6	"Board" means the death care industry board.
7	"Cemetery salesperson" means a person who sells or offers
8	to sell; buys or offers to buy; lists; leases or offers to
9	lease; or solicits or negotiates the purchase, sale, lease, or
10	exchange of cemetery property or interment services.
11	"Funeral director" means a person who:
12	(1) Engages in one or more of the following practices:
13	(A) Directing or supervising funerals;
14	(B) Preparing human remains for burial by any means,
15	other than by embalming;
16	(C) Disposing of human remains;

1	(D)	Making of arrangements to provide for funeral
2		services;
3	(E)	Selling funeral services or merchandise; or
4	(F)	Making financial arrangements for the rendering
5		of the services or the sale of funeral
6		merchandise; or
7	(2) Hold	s themselves out to the public as either a funeral
8	dire	ctor or someone engaged in one of the practices
9	desc	ribed herein.

- 4 (e) Each person appointed to the board shall have a
- 5 four-year term; provided that the initial appointments shall be
- 6 for staggered terms, as determined by the governor. The
- 7 governor shall immediately fill any vacancy by appointing a new
- 8 member for a four-year term beginning on the date of
- 9 appointment. No member shall serve more than two consecutive
- 10 terms, except that a member serving on the board pursuant to

- 13 (f) A board member shall be immediately removed from the

4	(g) The board shall meet at least semiannually and may
5	meet at any other times as the board deems necessary.
6	(h) The members of the board shall serve without
7	compensation but shall be reimbursed for expenses, including
8	reasonable travel expenses, necessary for the performance of
9	their duties.
10	§469- Death care industry board; powers and duties.
11	(a) In addition to any other powers and duties authorized by
12	law, the board shall have all the powers necessary to effectuate
13	the purposes of this part, including the power to:
14	(1) Approve examinations for licensure as funeral
15	directors or cemetery salespersons;
16	(2) Grant, revoke, suspend, or refuse to renew a license
17	as provided in this part;
18	(3) Receive and conduct investigations regarding
19	complaints made against licensees or any other person
20	performing the services of a funeral director or
21	cemetery salesperson in violation of this part;

1	(4)	Hold hearings, subpoena witnesses and documents,
2		administer oaths, and receive affidavits and oral
3		testimony; and
4	(5)	Adopt rules pursuant to chapter 91 to effectuate the
5		purposes of this part.
6	(b)	The board:
7	(1)	Shall, at least once every two years, inspect the
8		premises and records of each funeral director and
9		cemetery salesperson licensed pursuant to this part;
10	(2)	May randomly inspect the premises and records
11		described in paragraph (1) at any time; and
12	(3)	May establish a self-inspection program;
13	provided	that the board shall only inspect the records described
14	herein to	the extent necessary to ensure compliance with this
15	part or a	ny rules adopted pursuant to this part, or both;
16	provided	further that the board shall not inspect any area of
17	the premi	ses described herein that is used as living quarters;
18	and provi	ded further that the board may adopt rules pursuant to
19	chapter 9	1 to establish criteria to exempt funeral directors and
20	cemetery	salespersons from the requirements of paragraph (1).
21	(c)	The board shall employ:

1	(1) At least one full-time equivalent (1.0 FTE) employee
2	to perform inspections under subsection (c)(1) and (2
3	and aid in the enforcement of the provisions of this
4	part and any rules adopted pursuant to this part; and
5	(2) Any other personnel necessary to assist the board in
6	the performance of its duties;
7	provided that the board shall not employ any person under this
8	paragraph who is a member of the board or actively engaged in a
9	profession or practice regulated by this part.
10	(d) After each revision to this part or any rules adopted
11	pursuant to this part, the board shall publish for distribution
12	to funeral directors, cemetery salespersons, and any other
13	interested persons, the provisions of this part and the rules
14	adopted pursuant to this part, except that any non-extensive
15	revisions to this part or any rules adopted under this part may
16	instead be published in supplementary form.
17	§469- Death care industry board special fund;
18	established. (a) There is established in the state treasury
19	the death care industry board special fund.
20	(b) The revenues of the special fund shall consist of
21	appropriations made by the legislature, fees charged by the

- 1 board, grants, gifts, any other moneys deposited into the
- 2 special fund in accordance with this part, and interest on
- 3 moneys deposited into the special fund.
- 4 (c) The special fund shall be used to administer and
- 5 enforce this part.
- 6 §469- Funeral directors and cemetery salespersons;
- 7 licensure. (a) No person shall practice as a funeral director
- 8 or cemetery salesperson in the State without having a valid
- 9 license in good standing issued by the board.
- 10 (b) The board shall adopt rules pursuant to chapter 91
- 11 establishing requirements for granting, revoking, suspending, or
- 12 refusing to renew the licenses of funeral directors and cemetery
- 13 salespersons, including qualifications, application
- 14 requirements, renewal requirements, and fees.
- 15 §469- Penalty. Any person who practices as a funeral
- 16 director or cemetery salesperson in violation of this part or
- 17 the rules adopted under this part shall be fined not less than
- 18 \$ nor more than \$ or imprisoned not less
- 19 than nor more than , or both."
- 20 SECTION 2. Section 26-9, Hawaii Revised Statutes, is
- 21 amended by amending subsection (c) to read as follows:



1 "(c) The board of acupuncture, board of public 2 accountancy, board of barbering and cosmetology, boxing 3 commission, Hawaii board of chiropractic, contractors license board, death care industry board, board of dentistry, board of 4 5 electricians and plumbers, elevator mechanics licensing board, 6 board of professional engineers, architects, surveyors, and 7 landscape architects, board of massage therapy, Hawaii medical 8 board, motor vehicle industry licensing board, motor vehicle 9 repair industry board, board of naturopathic medicine, board of 10 nursing, Hawaii board of optometry, pest control board, board of 11 pharmacy, board of physical therapy, board of psychology, board 12 of private detectives and guards, real estate commission, Hawaii 13 board of veterinary medicine, board of speech pathology and 14 audiology, and any board, commission, program, or entity created 15 pursuant to or specified by statute in furtherance of the 16 purpose of this section including but not limited to section 17 26H-4, or chapters 484, 514B, and 514E shall be placed within the department of commerce and consumer affairs for 18 19 administrative purposes.

The public utilities commission shall be placed, for

- 1 and consumer affairs. Notwithstanding section 26-9(e), (f),
- 2 (g), (h), (j), (k), (l), (m), (n), (p), (q), (r), and (s), and
- 3 except as permitted by sections 269-2 and 269-3, the department
- 4 of commerce and consumer affairs shall not direct or exert
- 5 authority over the day-to-day operations or functions of the
- 6 commission."
- 7 SECTION 3. Section 441-25, Hawaii Revised Statutes, is
- 8 amended to read as follows:
- 9 "§441-25 [License] Real estate license not required to act
- 10 as cemetery or pre-need funeral salesperson. Chapter 467,
- 11 relating to real estate brokers and salespersons, shall not be
- 12 applicable to cemetery salespersons [-]; provided that cemetery
- 13 salespersons shall be licensed pursuant to chapter 469."
- 14 SECTION 4. Section 469-2, Hawaii Revised Statutes, is
- 15 amended to read as follows:
- 16 "§469-2 Rules. The department of health may prescribe
- 17 [such] any rules as it deems reasonable and proper relating to
- 18 the practice of embalming[, to the business of an undertaker,]
- 19 or to the sanitary condition of places where [such] the business
- 20 or practice of embalming is conducted. [The rules of the
- 21 department may prescribe an original registration fee for the



- 1 engaging by any person in the business of an undertaker and an
- 2 annual renewal fee.] "
- 3 SECTION 5. Section 469-3, Hawaii Revised Statutes, is
- 4 amended to read as follows:
- 5 "\$469-3 Renewal of license. Each licensed embalmer [or
- 6 licensed undertaker or funeral director] shall, between July 1
- 7 and 10 of each year, renew the embalmer's [or undertaker's or
- 8 funeral director's license by registering with the department
- 9 of health and by paying a renewal fee. Every license that is
- 10 not so renewed shall expire on August 1 and shall not be renewed
- 11 except upon the payment of a delinquent fee."
- 12 SECTION 6. Section 469-5, Hawaii Revised Statutes, is
- 13 amended to read as follows:
- 14 "§469-5 Disposition of fees. All fees collected [by the
- 15 board] pursuant to this part shall be deposited by the
- 16 department of health with the director of finance to the credit
- 17 of the general fund."
- 18 SECTION 7. Section 469-6, Hawaii Revised Statutes, is
- 19 amended to read as follows:
- 20 "§469-6 Revocation of license. A license issued pursuant
- 21 to this part may be revoked by the department of health upon



- 1 proof to its satisfaction of violation of any rule or regulation
- 2 of the department in any respect in regard thereto. Every
- 3 person so charged shall be given notice and opportunity for
- 4 hearing in conformity with chapter 91."
- 5 SECTION 8. Section 469-8, Hawaii Revised Statutes, is
- 6 amended to read as follows:
- 7 "\$469-8 Penalty. Any person who practices as an embalmer
- 8 [or undertaker] without being registered with the department of
- 9 health as herein provided shall be fined not less than \$50 nor
- 10 more than \$250 or imprisoned not less than thirty days nor more
- 11 than ninety days, or both."
- 12 SECTION 9. Chapter 469, Hawaii Revised Statutes, is
- 13 amended by changing its title to read as follows:
- 14 "[UNDERTAKERS,] EMBALMERS, FUNERAL DIRECTORS, CEMETERY
- 15 SALESPERSONS"
- 16 SECTION 10. Chapter 469, Hawaii Revised Statutes, is
- 17 amended by designating sections 469-1 to 469-8 as part I and
- 18 inserting a title before section 469-1 to read as follows:
- 19 "PART I. EMBALMERS"

- 1 SECTION 11. This Act does not affect rights and duties
- 2 that matured, penalties that were incurred, and proceedings that
- 3 were begun before its effective date.
- 4 SECTION 12. Statutory material to be repealed is bracketed
- 5 and stricken. New statutory material is underscored.
- 6 SECTION 13. This Act shall take effect on January 1, 2024.
