A BILL FOR AN ACT

RELATING TO SIDEWALKS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that keeping public 2 sidewalks free and clear of obstructions and other hazards is a 3 matter of statewide concern. Sidewalks serve several important 4 functions, including allowing for safe pedestrian movement, 5 facilitating deliveries of goods and services, and providing 6 convenient access to business establishments. However, when 7 sidewalks are obstructed by persons who are sitting or lying down, the sitting or lying persons are at risk of injury from 8 9 passing motorists. Further, other members of the public are 10 deprived of walking as a healthy and green option to access shops, restaurants, and essential services. Moreover, the 11 12 delivery of goods and services is hampered, which interferes 13 with commercial activities necessary to a robust economy. 14 more egregious cases, persons having mobility issues are forced 15 to navigate around the person who is sitting or lying on the 16 sidewalk.

1	It is not the legislature's intent to unduly burden an
2	individual's First Amendment right to speak, protest, or engage
3	in other lawful activity on a public sidewalk. This Act
4	contains exceptions for expressive activities as well as other
5	situations, such as those involving medical emergencies.
6	Accordingly, the purpose of this Act is to establish the
7	petty misdemeanor offense of sitting or lying on a public
8	sidewalk.
9	SECTION 2. Chapter 711, Hawaii Revised Statutes, is
10	amended by adding a new section to be appropriately designated
11	and to read as follows:
12	"§711- Sitting or lying on a public sidewalk. (1) A
13	person commits the offense of sitting or lying on a public
14	sidewalk if the person intentionally or knowingly sits or lies
15	on a:
16	(a) Publicly owned or maintained sidewalk; or
17	(b) Tarp, towel, sheet, blanket, sleeping bag, bedding,
18	planter, chair, bench, or any other object or material
19	placed upon a publicly owned or maintained sidewalk.
20	(2) The prohibitions in subsection (1) shall not apply to:

1	<u>(a)</u>	Any person sitting or lying on a sidewalk due to a
2		medical emergency;
3	(b)	Any person who, as a result of a disability, is using
4		a wheelchair or other similar device to move about the
5		sidewalk;
6	<u>(c)</u>	Any person sitting or lying on a sidewalk for the
7		purpose of engaging in an expressive activity;
8	<u>(d)</u>	Any person sitting on a sidewalk while attending or
9		viewing any parade, festival, performance, rally,
10		demonstration, or similar event conducted on the
11		street pursuant to a permit issued by a governmental
12	·	<pre>entity;</pre>
13	<u>(e)</u>	Any person engaged in a maintenance, repair, or
14		construction activity on behalf of a governmental
15	•	entity or a public utility;
16	<u>(f)</u>	Any child who is sitting or lying in a baby carriage,
17		stroller, or carrier, or similar device, to move about
18		the sidewalk;
19	<u>(g)</u>	Any person sitting on a chair or bench located on the
20		sidewalk that is placed there by a governmental
21		entity; or

1	<u>(h)</u>	Any person sitting in line for goods or services,
2		unless the person or person's possessions impede the
3	•	ability of pedestrians to travel along the length of
4		the sidewalk or enter a doorway or other entrance
5		alongside the sidewalk.
6	(3)	No person shall be cited or arrested for violating
7	this sect	ion unless the person engages in conduct prohibited by
8	this sect	ion after having been notified by a law enforcement
9	officer t	hat the conduct violates this section.
10	(4)	Sitting or lying on a public sidewalk is a petty
11	misdemean	or.
12	(5)	As used in this section:
13	"Exp	ressive activity" means speech or conduct, the
14	principal	object of which is the expression, dissemination, or
15	communica	tion by verbal, visual, literary, or auditory means of
16	political	, religious, philosophical, or ideological opinions,
17	views, or	ideas, and for which no fee is charged or required as
18	a conditi	on of participation in or attendance at the activity.
19	The term	does not include sports events such as marathons;
20	fundraisi	ng events; beauty contests; commercial events; cultural

1	celebrations; or other events having the principal purpose of
2	entertainment.
3	"Sidewalk" means:
4	(a) That portion of a street between the curb lines, or
5	the lateral lines of a roadway, and the adjacent
6	property lines, intended for use of pedestrians; or
7	(b) A pedestrian passageway that crosses private property
8	pursuant to a public easement, resulting from an
9	obstruction on public land that requires pedestrians
10	to pass along adjacent private property."
11	SECTION 3. This Act does not affect rights and duties that
12	matured, penalties that were incurred, and proceedings that were
13	begun before its effective date.
14	SECTION 4. New statutory material is underscored.
15	SECTION 5. This Act shall take effect upon its approval.
