7	(d) As used in this section, "minerals" means natural

9	deposits of metals, nonmetallic minerals, gemstones, ores, gold,

### Report Title:

Environmental Protection; Deep Sea Mining; Permits; Prohibitions

### Description:

Generally prohibits the removal of minerals from the seabed in all state marine waters. Prohibits the issuance of permits for the mooring, docking, or operation of any vessel designed or intended for removal of minerals from the seabed. Provides for exceptions relating to beach replenishment, research purposes, and native Hawaiian cultural practices.
