The person shall relinquish possession and control 3 of any firearm and ammunition owned by that person to the police 4 department of the appropriate county for safekeeping for the 5 6 duration of the order or extension thereof. At the time of 7 service of a protective order or restraining order involving 8 firearms and ammunition issued by any court, a police officer 9 may take custody of any and all firearms and ammunition in plain sight, those discovered pursuant to a consensual search, and 10 11 those firearms surrendered by the person restrained. If the 12 person restrained is the registered owner of a firearm and knows 13 the location of the firearm, but refuses to surrender the 14 firearm or disclose the location of the firearm, the person 15 restrained shall be guilty of a misdemeanor. In any case, when 16 a police officer is unable to locate the firearms and ammunition 17 either registered under this chapter or known to the person 18 granted protection by the court, the police officer shall apply 19 to the court for a search warrant pursuant to chapter 803 for 20 the limited purpose of seizing the firearm and ammunition."

that the electric gun may be used to threaten, injure, or abuse
any person. The ex parte order shall be effective upon service
pursuant to section 586-6.

5 At the time of service of a restraining order involving 6 electric guns issued by any court, the police officer may take 7 custody of any and all electric guns in plain sight, those 8 discovered pursuant to a consensual search, and those electric 9 guns surrendered by the person restrained.

10 For the purposes of this subsection, "good cause" shall not 11 be based solely upon the consideration that the person subject 12 to restraint pursuant to an order of any court, including an ex 13 parte order as provided for in this subsection, is required to 14 possess or carry an electric gun [during the course of the 15 person's employment.] for the person's own safety. "Good cause" includes but is not limited to the protection and safety of the 16 17 person to whom a restraining order is granted."

18 SECTION 4. This Act does not affect rights and duties that 19 matured, penalties that were incurred, and proceedings that were 20 begun before its effective date.
