# A BILL FOR AN ACT

RELATING TO OCEAN RECREATION.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. The legislature finds that small boat harbors  
2 and boating facilities are some of the most heavily trafficked  
3 facilities in the State, used by residents and tourists alike.  
4 The division of conservation and resources enforcement of the  
5 department of land and natural resources is responsible for  
6 enforcing all statutes and administrative rules of the  
7 department, but spends a large part of its time responding to  
8 violations in small boat harbors and boating facilities.

9           Much of the enforcement efforts at small boat harbors and  
10 boating facilities are necessary to ensure public health and  
11 safety, such as responding to vandalism, theft, trespassing, and  
12 squatting. In order to deter violators and repeat offenders,  
13 stricter penalties are needed.

14           The language of section 200-14, Hawaii Revised Statutes, is  
15 not clear regarding whether criminal penalties are authorized  
16 for violations of the section, which has hindered enforcement  
17 efforts. Therefore, the purpose of this Act is to clarify that



1 criminal penalties are authorized under section 200-14, Hawaii  
2 Revised Statutes.

3 SECTION 2. Section 200-14, Hawaii Revised Statutes, is  
4 amended to read as follows:

5 "§200-14 Violation of rules; penalty. (a) Except as  
6 provided in subsection (b), any person who violates this part,  
7 or any rule adopted by the department [~~under~~] pursuant to this  
8 part [~~or who violates this part~~], shall be guilty of a petty  
9 misdemeanor and fined not more than \$1,000 [~~or less than \$50~~],  
10 or sentenced to a term of imprisonment of not more than thirty  
11 days, or both, for each violation [~~, and any~~]. Each day or  
12 instance of violation shall be deemed a separate offense.  
13 Additionally, any vessel, the agents, owner, or crew of which  
14 violate [~~the~~] this part, or any rules [~~of the department or~~]  
15 adopted by the department pursuant to this part, shall be fined  
16 not more than \$1,000 [~~or less than \$50~~] for each violation [~~,~~  
17 ~~provided that in~~]. In addition to or as a condition to the  
18 suspension of [~~the fines and~~] any penalties [~~,~~] imposed pursuant  
19 to this section, the environmental court may deprive the  
20 offender of the privilege of operating or mooring any vessel in



1 state waters for a period of not more than thirty days[-] for  
2 each violation.

3 (b) Any person who violates any rule adopted by the  
4 department under this part regulating vehicular parking or  
5 traffic movement shall have committed a traffic infraction as  
6 set forth in chapter 291D, the adjudication of which shall be  
7 subject to the provisions contained therein. A person found to  
8 have committed such a traffic infraction shall be fined not more  
9 than:

- 10 (1) \$100 for a first violation;  
11 (2) \$200 for a second violation; and  
12 (3) \$500 for a third or subsequent violation.

13 (c) Notwithstanding [~~the provisions of~~] subsection (a)  
14 [~~establishing a fine of not more than \$1,000 or less than \$50~~  
15 ~~for each violation~~], any person who violates any rule adopted by  
16 the department relating to unauthorized discharge, dumping, or  
17 abandoning, in any state boating facility or state waters, of  
18 any petroleum product, hazardous material, or sewage in  
19 violation of the state water quality standards established by  
20 the department of health, shall be fined not more than \$10,000  
21 for each day or instance of violation[~~, and~~], or sentenced to a



1 term of imprisonment of not more than thirty days, or both.  
2 Each day or instance of each violation shall be deemed a  
3 separate offense. Additionally, any vessel, the agents, owner,  
4 or crew of which violate the rules of the department shall be  
5 fined not more than \$10,000 for each day of violation."

6 SECTION 3. Statutory material to be repealed is bracketed  
7 and stricken. New statutory material is underscored.

8 SECTION 4. This Act shall take effect upon its approval.
