#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 149A-51, Hawaii Revised Statutes, is 1 amended to read as follows: 2 "§149A-51 Advisory committee. (a) There shall be an 3 advisory committee on pesticides composed of but not limited to 4 the chairperson, or the chairperson's designated representative, 5 who shall head the committee and one representative each from 6 the department of health, department of land and natural 7 resources, University of Hawaii college of tropical agriculture 8 and human resources, [sugar industry, pineapple industry,] 9 coffee industry, diversified agriculture industry, Hawaii Farm 10 Bureau [Federation], pesticide industry, structural pest control 11 industry, an environmental organization, a citizen group, and a 12 landscape professional. 13 Members of the advisory committee shall be appointed 14 by the governor from a list of persons recommended by the 15 respective agencies and industries in accordance with section 16 26-34. 17
