#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

	BECTION 1. Section 707 702, nawati kevised statutes, is

1 (3) For purposes of this section: 2 "Dangerous drug" has the same meaning as "dangerous drugs" as defined by section 712-1240; and 3 4 "Distributes" has the same meaning as "to distribute" as 5 defined by section 712-1240. 6  $\left[\frac{(2)}{(2)}\right]$  (4) In a prosecution for murder or attempted murder 7 in the first and second degrees it is an affirmative defense, 8 which reduces the offense to manslaughter or attempted 9 manslaughter, that the defendant was, at the time the defendant 10 caused the death of the other person, under the influence of 11 extreme mental or emotional disturbance for which there is a **12** reasonable explanation. The reasonableness of the explanation **13** shall be determined from the viewpoint of a reasonable person in the circumstances as the defendant believed them to be; provided 14 15 that an explanation that is not otherwise reasonable shall not **16** be determined to be reasonable because of the defendant's discovery, defendant's knowledge, or the disclosure of the other **17** 18 person's actual or perceived gender, gender identity, gender 19 expression, or sexual orientation, including under circumstances 20 in which the other person made an unwanted nonforcible romantic 21 or sexual advance toward the defendant, or in which the 22 defendant and the other person dated or had a romantic

If the defendant's explanation includes the 2 discovery, knowledge, or disclosure of the other person's actual or perceived gender, gender identity, gender expression, or 3 4 sexual orientation, the court shall instruct the jury to 5 disregard biases or prejudices regarding the other person's 6 actual or perceived gender, gender identity, gender expression, or sexual orientation in reaching a verdict. 7 8 [<del>(3)</del>] (5) Manslaughter is a class A felony." 9 SECTION 2. This Act does not affect rights and duties that matured, penalties that were incurred, and proceedings that were **10** 11 begun before its effective date. 12 SECTION 3. TITLE:

A BILL FOR AN ACT RELATING TO MANSLAUGHTER.

PURPOSE:

To authorize prosecution for manslaughter where dangerous drug distribution results in

a fatal overdose.

MEANS:

Amend section 707-702, Hawaii Revised

Statutes.

JUSTIFICATION:

Hawaii has seen a rise in overdose deaths involving fentanyl. This bill will help address the problem by authorizing prosecutions against illegal drug dealers who cause the death of the user, and it will enable prosecution at the state and county level.

Impact on the public: This bill will give families of overdose victims better access to justice by allowing prosecution of drug dealers who profit from sales of illegal drugs without regard to the toxicity of those drugs. Allowing prosecution of these drug dealers will improve public safety by holding such dealers accountable and deterring others from such activities.

Impact on the department and other agencies: This bill will give law enforcement another tool in the fight against fentanyl overdose deaths. Prosecutors and law enforcement agencies will be affected.
