#### JUSTIFICATION SHEET

DEPARTMENT: Business, Economic Development, and Tourism

- TITLE: A BILL FOR AN ACT RELATING TO ENVIRONMENTAL IMPACT STATEMENTS.
- PURPOSE: To exempt affordable housing projects within the state urban land use district or up to fifteen acres of land in the state agricultural land use district from current environmental assessment (EA) requirements.
- MEANS: Add a new section to chapter 343, Hawaii Revised Statutes.
- JUSTIFICATION: This measure would address the lengthy entitlement process for affordable housing development by expanding the criteria that make affordable housing projects eligible for an EA exemption.

<u>Impact on the public:</u> Increases the availability of affordable housing to help keep essential workers from leaving the state due to high housing costs, which will have a long-term positive impact on economic growth.

Impact on the department and other agencies: The Hawaii Housing Finance and Development Corporation and other housing agencies will be able to exempt more affordable housing projects from EAs and expedite the development process for those projects.
