A BILL FOR AN ACT

RELATING TO TRANSIT-ORIENTED DEVELOPMENT PLANNING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to replace the 2 director of law enforcement with the director of corrections and 3 rehabilitation as a member of the Hawaii interagency council for 4 transit-oriented development. The director of public safety was 5 named as a member of the Hawaii interagency council for transitoriented development when it was established in 2016. .6 In the codification of Act 278, Session Laws of Hawaii 2022, which 7 8 reorganized the department of public safety, section 226-64(a), 9 Hawaii Revised Statutes, was amended to replace the director of 10 public safety with the director of law enforcement. As the council advises on state facilities in transit-oriented 11 12 development areas, the director of corrections and 13 rehabilitation, who has administrative responsibilities for 14 correctional and rehabilitation facilities statewide, is the 15 more appropriate director to serve on the transit-oriented 16 development council.

SECTION 2. Section 226-64, Hawaii Revised Statutes, is
amended by amending subsection (a) to read as follows:

Amend section 226-64(a), Hawaii Revised Statutes (HRS).

The director of the Department of Public Safety was named as a member of the Hawaii Interagency Council for Transit-Oriented Development (TOD Council) when the TOD Council was established in 2016. Act 278, Session Laws of Hawaii (SLH) 2022, reorganized the Department of Public Safety (PSD) into two departments: the Department of Law Enforcement and the Department of Corrections and Rehabilitation. In codifying Act 278, section 226-64(a) was amended to replace the Director of Public Safety with the Director of Law Enforcement. As the TOD Council advises on matters related to the planning and development of State facilities in transit-oriented development areas, the Director of Corrections and Rehabilitation, who has administrative responsibilities for correctional and rehabilitation facilities statewide, is the more appropriate director to serve on the TOD Council. The provisions related to the new Department of Corrections and Rehabilitation are to take effect on January 1, 2024.

Impact on the department and other agencies: There is no impact on the department or other agencies, as PSD has continued to
