SECTION 14. Salary increases and cost adjustments provided
 in this Act for any officer or employee whose compensation is
 paid, in whole or in part, from federal, special, or other funds
 shall be paid wholly or proportionately, as the case may be,
 from the respective funds.

6 SECTION 15. Funds appropriated or authorized by this Act
7 that are not expended or encumbered by June 30, 2024, and
8 June 30, 2025, of the respective fiscal years, shall lapse as of
9 those dates.

SECTION 16. In accordance with section 9 of article VII of 10 the Constitution of the State of Hawaii and sections 37-91 and 11 12 37-93, Hawaii Revised Statutes, the legislature has determined that the general fund expenditure ceiling for fiscal year 2023-13 2024 has already been exceeded by \$1,005,342,735 or 9.4 per 14 15 cent. The appropriations contained in this Act will cause the state general fund expenditure ceiling for fiscal year 2023-2024 16 17 to be further exceeded by \$ or per cent. This declaration takes into account the additional general fund 18 19 appropriations authorized for fiscal year 2023-2024 in this Act 20 only. The reasons for exceeding the general fund expenditure 21 ceiling are that:
