## A BILL FOR AN ACT

RELATING TO THE HURRICANE RESERVE TRUST FUND.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 237-31, Hawaii Revised Statutes, is
amended to read as follows:

3 "§237-31 Remittances. All remittances of taxes imposed by 4 this chapter shall be made by money, bank draft, check, 5 cashier's check, money order, or certificate of deposit to the 6 office of the department of taxation to which the return was 7 transmitted. The department shall issue its receipts therefor 8 to the taxpayer and shall pay the moneys into the state treasury 9 as a state realization, to be kept and accounted for as provided 10 by law; provided that:

11 (1) A sum, not to exceed \$5,000,000, from all general 12 excise tax revenues realized by the State shall be 13 deposited in the state treasury in each fiscal year to 14 the credit of the compound interest bond reserve fund; 15 <u>and</u>

16 [(2) A sum from all general excise tax revenues realized by 17 the State that is equal to one half of the total

Moneys deposited in the hurricane 3 reserve trust fund and any accounts thereunder or any other 4 trust fund or account shall be held by the fund, as trustee, in 5 a depository as defined in section 38-1 or according to a 6 similar arrangement at the discretion of the board, including, 7 but not limited to, trust or custodial accounts created for the 8 benefit of the fund's secured parties under contractual claims 9 financing arrangements. These moneys may be invested and 10 reinvested in accordance with the plan of operation. 11 Disbursements from the trust funds shall not be subject to 12 chapter 103D and shall be made in accordance with procedures adopted by the board." 13 14 SECTION 3. Statutory material to be repealed is bracketed 15 and stricken. New statutory material is underscored. 16 SECTION 4. This Act shall take effect on July 1, 3000.
