A BILL FOR AN ACT

RELATING TO THE SCHOOL FACILITIES SPECIAL FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act is recommended by the governor for
- 2 immediate passage in accordance with section 9 of article VII of
- 3 the Hawaii State Constitution.
- 4 SECTION 2. Section 302A-1706, Hawaii Revised Statutes, is
- 5 amended by amending subsections (b) through (e) to read as
- 6 follows:
- 7 "(b) The [authority] department shall establish and
- 8 appropriately name subaccounts2742 within the school facilities
- 9 special fund to accept deposits of revenues from school impact
- 10 fees that are required to be expended within a specific school
- 11 impact district pursuant to section 302A-1608(a) or restricted
- 12 for a specified purpose pursuant to part V, subpart B of this
- 13 chapter.
- (c) The school facilities special fund shall be
- 15 administered by the [authority] department and used to fund any
- 16 school development, planning, or construction project, including

- 1 prekindergarten facilities, within the jurisdiction of the
- 2 authority.
- 3 (d) Subject to chapter 84, any other law to the contrary
- 4 notwithstanding, the governor may authorize expenditures from
- 5 the school facilities special fund of any donation, grant,
- 6 bequest, and devise of money from any private institution,
- 7 person, firm, or corporation for the purposes of funding the
- 8 salaries of the executive director and any officers, agents, and
- 9 employees of the authority. If all or any portion of any salary
- 10 of the executive director or any officer, agent, or employee of
- 11 the authority is funded pursuant to this subsection, the
- 12 [authority] department shall submit a report to the legislature
- 13 detailing the use of any funds authorized under this subsection
- 14 no later than twenty days prior to the convening of the next
- 15 regular session following the expenditure authorization.
- 16 (e) The [authority] department shall submit to the
- 17 director of finance a report that shall be prepared in the form
- 18 prescribed by the director of finance and shall identify the
- 19 total amount of funds in the school facilities special fund that
- 20 will carry over to the next fiscal year. The [authority]
- 21 department shall submit the report to the director of finance

- 1 within ninety days of the close of each fiscal year and a copy
- 2 of the information contained in the report to the director of
- 3 finance shall be included within the authority's report to the
- 4 legislature pursuant to section 302A-1707."
- 5 SECTION 3. Act 257, Session Laws of Hawaii 2022, as
- 6 amended by Act 175, Session Laws of Hawaii 2023, is amended as
- 7 follows:
- 8 1. By adding a new section to read as follows:
- 9 "SECTION 1A. The director of finance is authorized to
- 10 issue general obligation bonds in the sum of \$100,000,000 or so
- 11 much thereof as may be necessary and the same sum or so much
- 12 thereof as may be necessary is appropriated for fiscal year
- 13 2023-2024 for deposit into the school facilities special fund.
- 14 The sum appropriated shall be expended by the department of
- 15 education for the purposes of this Act; provided that the
- 16 appropriation authorized by this Act shall not lapse at the end
- of the fiscal biennium for which the appropriation is made;
- 18 provided further that all moneys from the appropriation
- 19 unencumbered as of June 30, 2025, shall lapse as of that date."
- 20 2. By amending sections 1 and 2 to read:

1	"SECTION 1. [There is appropriated out of the general
2	revenues of the State of Hawaii the sum of \$200,000,000 or so
3	much thereof as may be necessary for fiscal year 2023 2024 to be
4	deposited into the school facilities special fund. Repealed.
5	SECTION 2. [There is appropriated out of the school
6	facilities special fund the sum of \$200,000,000 or so much
7	thereof as may be necessary for fiscal year 2023-2024 for the
8	school facilities authority to expand access to pre kindergarten
9	to eligible children of the State. The school facilities
10	authority may expend the moneys appropriated in this section on:
11	(1) The construction of new school facilities;
12	(2) The renovation, improvement, and expansion of existing
13	school-facilities to increase pre-kindergarten student
14	capacity; and
15	(3) Any other costs the school facilities authority deems
16	appropriate to increase pre kindergarten student
17	capacity within the State.
18	The sum appropriated shall be expended by the school
19	facilities authority for the purposes of this Act; provided that
20	the appropriation authorized by this Act shall not lapse at the
21	end of the fiscal biennium for which the appropriation is made;

- 1 provided further that the appropriation authorized by this Act
- 2 shall lapse on June 30, 2024.] Repealed."
- 3 SECTION 4. Statutory material to be repealed is bracketed
- 4 and stricken. New statutory material is underscored.
- 5 SECTION 5. This Act shall take effect upon its approval.

DOE; SFA; School Facilities Special Fund; General Obligation Bond Appropriations

Description:

Replaces the School Facilities Authority with the Department of Education as the administrator of the School Facilities Special Fund. Changes the means of financing for a portion of funds appropriated for deposit into the School Facilities Special Fund to expand pre-kindergarten student capacity within the State from general funds to general obligation bond funds. Repeals the funds appropriated into and out of the School Facilities Special Fund by Act 257, SLH 2022, as amended. (SD2)
