A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that the Hawaii health
2	corps program was established in 2012 with a focus on
3	encouraging certain healthcare providers to serve in counties
4	that are experiencing shortages of physicians, physician
5	assistants, and nurse practitioners, with a priority given to a
6	rural area county.
7	The legislature further finds that since that time, while
8	the need for these providers in these areas remains, there is ar
9	increased need for a wider range of health care providers by
10	professions, as well as a pressing need for practitioners in
11	mental health.
12	The legislature further finds that on September 9, 2023,
13	the State launched the Hawaii healthcare education loan
14	repayment program (HELP), which is alleviating the educational
15	debt of 492 medical and healthcare professionals. Because of
16	the expanded scope and purpose of HELP, the purpose of this Act
17	is to slarify the name of the Hawaii health sorns program and

- 1 rename it to the Hawaii rural healthcare provider loan program
- 2 to better reflect the purpose of the program.
- 3 SECTION 2. Section 309H-1, Hawaii Revised Statutes, is
- 4 amended by amending the definition of "loan repayment" or
- 5 "repayment of loan" to read as follows:
- 6 ""Loan repayment" or "repayment of loan" means the payment
- 7 of up to twenty per cent of a Hawaii [health corps] rural
- 8 healthcare provider loan program participant's health care
- 9 training costs including but not limited to tuition not
- 10 exceeding \$35,000 per year for a maximum of five years of
- 11 repayment."
- 12 SECTION 3. Section 309H-2, Hawaii Revised Statutes, is
- 13 amended to read as follows:
- 14 "§309H-2 Hawaii [health corps] rural health care provider
- 15 loan program established. The Hawaii [health corps] rural
- 16 healthcare provider loan program is established to encourage
- 17 physicians, physician assistants, and nurse practitioners to
- 18 serve in counties having a shortage of physicians, physician
- 19 assistants, and nurse practitioners, with priority given to a
- 20 rural area county. The Hawaii [health corps] rural healthcare
- 21 provider loan program shall be administered by the University of
- 22 Hawaii John A. Burns school of medicine and the University of

18	(5)	Collect and manage reimbursements from participants
19		who do not meet their service commitments under the
20		Hawaii rural health care provider loan repayment
21		program;

1	(6)	Publicize the program, particularly to maximize	
2		participation by individuals who live in areas of a	
3		county where there is a shortage of physicians,	
4		physician assistants, and nurse practitioners;	
5	(7)	Solicit and accept grants and donations from public	
6		and private sources for the Hawaii rural health care	
7		provider loan repayment program, including maximizing	
8		the use of federal matching funds; and	
9	(8)	Establish criteria and procedures for calling Hawaii	
10		[health corps] rural healthcare loan program	
11		participants into service during an emergency or	
12		disaster."	
13	SECT	ION 4. Section 309H-3, Hawaii Revised Statutes, is	
14	amended to	o read as follows:	
15	"[4]	§309H-3[] Hawaii rural health care provider loan	
16	repayment	program. (a) There is created [within the Hawaii	
17	health co	rps program,] the Hawaii rural health care provider	
18	loan repa	yment program to be administered by the University of	
19	Hawaii Jo	hn A. Burns school of medicine and the University of	
20	Hawaii at	Manoa school of nursing and dental hygiene in	
21	partnership with a lending financial institution whose		
22	operation	s are principally conducted in Hawaii. The Hawaii	

- 1 rural health care provider loan repayment program shall provide
- 2 loan repayments to eligible physicians, physician assistants,
- 3 and nurse practitioners who make the service commitment under
- 4 subsection (b). The University of Hawaii John A. Burns school
- 5 of medicine and the University of Hawaii at Manoa school of
- 6 nursing and dental hygiene shall make loan repayments directly
- 7 to the financial institution under subsection (b) to offset the
- 8 loan repayment for which the Hawaii rural health care provider
- 9 loan repayment program recipient would otherwise be
- 10 liable. Loan repayments shall commence upon the commencement of
- 11 loan repayments by the Hawaii rural health care provider loan
- 12 repayment program recipient to the lending financial
- 13 institution. The University of Hawaii John A. Burns school of
- 14 medicine and the University of Hawaii at Manoa school of nursing
- 15 and dental hygiene shall prioritize loan repayments in
- 16 accordance with the greatest specialty shortages for the
- 17 particular county.
- 18 (b) The Hawaii rural health care provider loan repayment
- 19 program shall provide loan repayments on behalf of licensed
- 20 physicians, physician assistants, and nurse practitioners who
- 21 agree to serve for five consecutive years as a physician,
- 22 physician assistant, or nurse practitioner in a county having a

- 1 shortage of physicians, physician assistants, and nurse
- 2 practitioners, with priority given to a rural area of that
- 3 particular county; provided that eligible physicians, physician
- 4 assistants, or nurse practitioners, as applicable, shall have
- 5 graduated from a duly accredited medical school or nursing
- 6 school within the United States; provided further that
- 7 preference shall be given to graduates of the University of
- 8 Hawaii John A. Burns school of medicine or the University of
- 9 Hawaii at Manoa school of nursing and dental hygiene, as
- 10 applicable.
- 11 (c) Eligible participants in the Hawaii rural health care
- 12 provider loan [+] repayment[+] program shall be determined by the
- 13 University of Hawaii John A. Burns school of medicine and the
- 14 University of Hawaii at Manoa school of nursing and dental
- 15 hygiene on a competitive basis and in accordance with subsection
- **16** (b).
- 17 (d) If a Hawaii rural health care provider loan repayment
- 18 program participant fails to satisfy the recipient's service
- 19 commitment under subsection (b), the Hawaii rural health care
- 20 provider loan repayment program participant shall be liable for
- 21 the repayment of the outstanding balance of the loan to the
- 22 lending financial institution under subsection (b). In

- 1 addition, the University of Hawaii John A. Burns school of
- 2 medicine and the University of Hawaii at Manoa school of nursing
- 3 and dental hygiene may seek reimbursement for any loan repayment
- 4 made by the University of Hawaii John A. Burns school of
- 5 medicine or the University of Hawaii at Manoa school of nursing
- 6 and dental hygiene on behalf of the Hawaii rural health care
- 7 provider loan repayment program participant.
- **8** (e) In accordance with chapter 103D, the University of
- 9 Hawaii John A. Burns school of medicine and the University of
- 10 Hawaii at Manoa school of nursing and dental hygiene may enter
- 11 into written contracts with collection agencies to collect
- 12 delinquent reimbursements of loan repayments. All payments
- 13 collected, exclusive of a collection agency's commissions, shall
- 14 revert and be credited to the Hawaii [health corps] rural
- 15 healthcare provider loan fund. A collection agency that enters
- 16 into a written contract with the University of Hawaii John A.
- 17 Burns school of medicine or the University of Hawaii at Manoa
- 18 school of nursing and dental hygiene to collect delinquent
- 19 reimbursements of loan repayments pursuant to this section may
- 20 collect a commission from the debtor in accordance with the
- 21 terms of, and up to the amounts authorized in, the written
- 22 contract."

1	SECTION 5. Section 309H-4, Hawaii Revised Statutes, is
2	amended to read as follows:
3	"§309H-4 Hawaii [health corps] rural health care provider
4	<u>loan</u> first responder service obligation. If an emergency or
5	disaster proclaimed under chapter 127A occurs, physicians,
6	physician assistants, and nurse practitioners participating in
7	the Hawaii [health corps] rural healthcare provider loan program
8	may be ordered into service by the governor as first responders
9	to serve in areas of the State and in a capacity determined by
10	the director of health."
1	SECTION 6. Statutory material to be repealed is bracketed
12	and stricken. New statutory material is underscored.
13	SECTION 7. This Act shall take effect upon its approval.

PURPOSE:

To rename the Hawaii Health Corps Program to the Hawaii Rural Health Care Provider Loan Program.

MEANS:

Amend Sections 309H-2, 309H-3, and 309H-4, Hawaii Revised Statutes.

JUSTIFICATION:

The Hawaii Health Corps Program was established in 2012 with a focus on encouraging certain healthcare providers to serve in counties that are experiencing shortages of physicians, physician assistants and nurse practitioners, with a priority given to a rural area county.

However, since its implementation, it has become clear that, while the need for these providers to serve these areas remains, there is also an increased need for a wider range of healthcare providers by professions, including mental health services to continue to enhance and improve access to medical healthcare services in these areas.

Recently, the Hawaii Healthcare Education
Loan Repayment Program (HELP) was
established to help alleviate the
educational debt of medical and healthcare
professionals who practice in Hawaii. Due
to HELP having an expanded scope and purpose
compared to the current Hawaii Health Corps
Program, it is necessary to clarify and
rename this program to better reflect its
purpose.
