TITLE:

A BILL FOR AN ACT RELATING TO THE ELECTRONIC PRESCRIPTION ACCOUNTABILITY SYSTEM.

PURPOSE:

(1) clarifies that an advanced practice registered nurse and pharmacist may access information stored in the electronic prescription accountability system (EPAS), and (2) allows controlled substances prescribers, dispensers, and pharmacists employed by United States Department of Veteran's Affairs facilities in Hawaii, who submit data of dispensing activity as described in section 329-101, Hawaii Revised Statutes (HRS), as well as authorized employees of the State of Hawaii Department of Human Services, Med-QUEST division to access prescription information stored in the EPAS.

MEANS:

Amend section 329-104(c), HRS.

JUSTIFICATION:

The proposed amendments enable the Department of Human Services, Med-QUEST division to comply with a federal requirement that all Med-QUEST providers use the Hawaii Prescription Drug Monitoring Program (PDMP) prior to the issuance of controlled substances prescriptions and clarifies who may access the EPAS.

Impact on the public: This bill is intended to aid: (1) advanced practice registered nurses and pharmacists, (2) controlled substances prescribers, dispensers, and pharmacists employed by United States Department of Veterans Affairs facilities in Hawaii, and (3) authorized employees of the Department of Human Services, Med-QUEST Division, by allowing them to access prescription information stored in the electronic prescription accountability system.

Impact on the department and other agencies:
These proposed amendments would: (1) assist
the Department's Narcotics Enforcement
Division by clarifying who may access
prescription information stored in the
electronic prescription accountability system,
and (2) Assist the Department of Human
Services, Med-QUEST division comply with
federal controlled substance data information
sharing mandates that require all Med-QUEST
providers use the PDMP prior to the issuance
of controlled substances prescriptions.
