A BILL FOR AN ACT

RELATING TO THE TAKING OF MARINE DEPOSITS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the department of
- 2 land and natural resources (department) regularly receives
- 3 requests for permits that involve taking of sand, dead coral or
- 4 coral rubble, rocks, soil, or other marine deposits from state
- 5 waters for research, education, management, or propagation
- 6 purposes. However, the department is not authorized to approve
- 7 these permit requests because section 171-58.5, Hawaii Revised
- 8 Statutes, does not currently allow for the take of these
- 9 resources for those purposes.
- 10 The purpose of this Act is to amend section 171-58.5,
- 11 Hawaii Revised Statutes, to allow for the taking of sand, dead
- 12 coral or coral rubble, rocks, soil, or other marine deposits
- 13 seaward from the shoreline for research, education, management,
- 14 or propagation purposes when authorized by permits issued by the
- 15 department of land and natural resources.
- 16 SECTION 2. Section 171-58.5, Hawaii Revised Statutes, is

Taking of Marine Deposits Seaward of the Shoreline

Description:

Authorizes the Department of Land and Natural Resources to approve permits for research, education, management, or propagation purposes that include the taking of sand, dead coral, coral rubble, rocks, soil, and other marine deposits seaward of the shoreline.

TITLE:

PURPOSE:

A BILL FOR AN ACT RELATING TO THE TAKING OF MARINE DEPOSITS.

To authorize the Department to approve permits for research, education, management, or propagation purposes that include the taking of sand, dead coral, coral rubble, rocks, soil, and other marine deposits seaward of the shoreline.

MEANS:

Amend section 171-58.5, Hawaii Revised Statutes (HRS).

JUSTIFICATION:

There is currently a need to authorize collection of sand, dead coral or coral rubble, rocks, soil, or other marine deposits for research, education, management, or propagation purposes. collection of select amounts of dead coral and coral rubble is requested frequently for various coral restoration purposes (to utilize as the base substrate to propagate Similarly, the collection of select coral). amounts of sand or other marine deposits is requested frequently for various animal husbandry activities (to maintain healthy exhibits in aquariums or academic programs with tanks holding aquatic organisms) and for general research purposes (composition or grain size analysis, detection of microplastics, and biodiversity assessment of organisms related to these substrates).

Under section 171-58.5, HRS, the mining or taking of sand, dead coral or coral rubble, rocks, soil, or other marine deposits seaward from the shoreline is prohibited, with select exceptions that do not currently include the take of these resources for research, education, management, or propagation purposes.

This bill would authorize the Department in allowing research, education, management, or propagation activities that request to collect sand, dead coral or coral rubble, rocks, soil, or other marine deposits to fulfill their objectives.

Impact on the public: The bill would support the collection of sand, dead coral or coral rubble, rocks, soil, or other marine deposits through special activity permits issued by the Department, thereby allowing permittees conducting research, education, management, or propagation activities to fulfill their objective.

Impact on the department and other agencies:
This bill would allow the Department to
issue permits to collect sand, dead coral or
coral rubble, rocks, soil, or other marine
deposits for research, education,
management, or propagation activities that
it deems appropriate and beneficial. It may
result in a slightly increased
administrative burden due to more permit
applications, but this increase would likely
be insignificant.
