A BILL FOR AN ACT

RELATING TO UNIVERSITY OF HAWAII CONFERENCE CENTER REVOLVING FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 304A-2273, Hawaii Revised Statutes, is 2 amended to read as follows:
- 3 "[+]\$304A-2273[+] [Community college] University of Hawaii
- 4 conference center revolving fund. (a) There is established the
- 5 [community college] university of Hawaii conference center
- 6 revolving fund for conference center programs conducted by the
- 7 [various community colleges.] university. The university may
- 8 establish and collect fees and charges for the costs of
- 9 providing these services. All fees, charges, and other moneys
- 10 collected in conjunction with the conference center [program]
- 11 programs of [each community college] the university shall be
- 12 deposited in separate accounts within the revolving fund. The
- 13 university may establish accounts under the university of Hawaii
- 14 conference center revolving fund to facilitate the
- 15 administration of this fund among the various campuses and
- 16 operating units of the university of Hawaii system. The

- 1 [chancellor of each community college or a designee] university
- 2 is authorized to expend funds from the appropriate account in
- 3 the revolving fund for all costs associated with conducting
- 4 conferences, seminars, and courses provided by the conference
- 5 center [program,] programs, including but not limited to
- 6 expenses for honoraria[τ]; hotel and room rentals[τ]; food and
- 7 refreshment $[\tau]$; printing and mailing $[\tau]$; airfare and per diem $[\tau]$
- 8 leis, ; lei; rental of audiovisual equipment[7]; and
- 9 [conference] other conference-related services, fees, supplies
- 10 and materials, without regard to section 103D-1002 and any

- 17 SECTION 2. Section 304A-2272, Hawaii Revised Statutes, is
- 18 repealed.
- 19 ["\frac{9304A-2272}{Conference center revolving fund; University
- 20 of Hawaii at Hilo. (a) There is established the conference
- 21 center revolving fund for conference center programs conducted



by the University of Hawaii at Hilo. All fees, charges, and 1 2 other moneys collected in conjunction with conference center 3 programs shall be deposited in the revolving fund. The chancellor of the University of Hawaii at Hilo or the 4 5 chancellor's designee is authorized to expend funds from the 6 revolving fund for all costs associated with conferences, 7 seminars, and courses provided by conference center programs, 8 including but not limited to expenses for honoraria, hotel and 9 room rentals, food and refreshment, printing and mailing, 10 airfare and per diem, lei, rental of audiovisual equipment, and 11 conference supplies and materials, without regard to any 12 competitive bidding requirements pursuant to chapter 103D. 13 (b) The chancellor of the University of Hawaii at Hilo 14 shall submit a report to the legislature no later than twenty 15 days prior to the convening of each regular session that 16 includes an accounting for all income and expenditures of the 17 revolving fund under this section." 18 SECTION 3. The conference center revolving fund repealed 19 by section 2 of this Act is abolished and any remaining 20 unencumbered balance shall lapse to the credit of the university

- 3 SECTION 4. Statutory material to be repealed is bracketed
- 4 and stricken. New statutory material is underscored.
- 5 SECTION 5. This Act shall take effect on July 1, 3000.

Establishes the University of Hawaii Conference Center Revolving Fund and authorizes the University of Hawaii to establish accounts under the fund to facilitate the administration of the revolving fund for conference center programs among various campuses and operating units of the University of Hawaii System. Repeals the Conference Center Revolving Fund for the University of Hawaii at Hilo. Lapses funds to the University of Hawaii Conference Center Revolving Fund. Effective 7/1/3000. (HD1)
