## A BILL FOR AN ACT

RELATING TO ELECTRIC UTILITY LINEMAN.

#### **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

SECTION 1. The legislature finds that it is critical to develop a local workforce of properly qualified, trained, and licensed electric utility linemen, which will protect the health and safety of the public and utility workers and improve and maintain Hawaii's electrical infrastructure. Recently, the tragic events on Maui made this need a top priority.

7 The legislature further finds that Act 183, Session Laws of 8 Hawaii 1971 (Act 183), established the board of electricians and 9 plumbers to oversee the licensing policies of the State's 10 electricians and plumbers and ensure the safety and welfare of 11 the public. Act 183 also exempted employees of a public utility 12 who perform electric utility work from these licensing 13 requirements.

14 Due to a growing need for electrical utility infrastructure 15 improvements, hardening, expansion, upgrades, repair, 16 maintenance work, and a qualified workforce to perform such 17 work, utilities began contracting out work previously performed

by employees of utilities. However, the board of electricians
 and plumbers has stated that electric utility work contracted
 out by a utility and performed by contractors falls outside of
 the exemption provided in Act 183.

5 In response, the legislature passed Act 65, Session Laws of 6 Hawaii 2013 (Act 65), which provided a limited exemption from 7 electrician licensing requirements for certain contractors retained by electric utilities who perform electric utility 8 9 work. Act 65 recognized the need for experienced and qualified 10 linemen in the State who can perform certain complex maintenance 11 and repair work affecting an electric utility and noted the potential impacts to the health and safety of the State and its 12 13 residents. Act 65 included a sunset date of June 30, 2018. 14 Industry stakeholders testified in 2013 in support of this 15 sunset date and indicated that, "[1]ocal training to develop a quality Hawaiian workforce would be the best long-term goal for 16 17 securing a safe and reliable electrical grid for our community." 18 The legislature further finds that Act 60, Session Laws of 19 Hawaii 2018, extended the sunset date of Act 65 for an 20 additional five years, with the intent to provide the industry with the time needed to develop a local workforce of trained and 21

qualified linemen to address the growing needs of Hawaii's
 electrical utilities.

Currently, there are established and state-approved 3 4 electric utility lineman apprenticeship programs available, with 5 others being developed. The National Electrical Safety Code, 6 adopted by the public utilities commission, is recognized as the 7 code and standard for training electric utility lineman and 8 covers the purpose and scope of work performed for the 9 generation, transmission, and distribution of electricity and 10 related electric utility facilities, equipment, and 11 infrastructure from the point of generation to the point of 12 service.

13 The legislature acknowledges the extreme working conditions 14 and inherent dangers of work performed by an electrical utility 15 lineman. Consistent with the Electrical Training Alliance, 16 which is the recognized industry partner by the International Brotherhood of Electrical Workers and the National Electrical 17 18 Contractors Association, the legislature recognizes the 19 significant and critical differences between an inside wireman 20 electrician trained and licensed under the purpose and scope of 21 the National Electrical Code and an electric utility lineman

18	the installation, maintenance, and operation of energized and
19	de-energized equipment and appurtenances associated with the
20	transmission and distribution of electricity from the
21	electricity's original source to the point of service."



1 SECTION 3. Section 448E-2, Hawaii Revised Statutes, is 2 amended to read as follows: 3 "§448E-2 Board; appointment. There is established the 4 board of electricians and plumbers consisting of [seven] nine 5 members. Two of the members shall be engaged in the electrical 6 trade, two of the members shall be engaged in electric utility 7 work, and two of the members shall be engaged in the plumbing 8 trade. Three of the members shall be private citizens not 9 connected with the industry." 10 SECTION 4. #### Report Title:

Journey Worker Electric Utility Lineman; Board of Electricians and Plumbers; Licensing; Requirements

#### Description:

Beginning 1/1/2027, establishes licensing requirements, including minimum standards and qualifications, for licensure as a journey worker electric utility lineman and expands the Board of Electricians and Plumbers to include members engaged in electric utility work. Repeals an existing exception to the impending sunset of the limited exemption from electrician licensing requirements that was originally enacted by Act 65, SLH 2013, and extended pursuant to Act 60, SLH 2018, and Act 68, SLH 2022. Effective 7/1/3000. (HD1)
