BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature appreciates all state employees, and values the vital work those employees perform for 2 the people of Hawaii. The legislature recognizes the importance 3 4 of investing in the state employees' professional development, so that they may continue to excel in their various roles. 5 6 Accordingly, the purpose of this Act is to appropriate 7 moneys to the department of human resources development for: 8 The establishment of positions to expand the (1)9 department's ability to offer professional development 10 programs for state employees; and 11 The learning management system. (2) 12 SECTION 2.
