## A BILL FOR AN ACT

RELATING TO FISHPONDS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 171-28, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "§171-28 Government-owned Hawaiian fishponds; sale
- 4 prohibition. (a) The board may investigate and develop
- 5 scientific commercial management practices for government-owned
- 6 Hawaiian fishponds and reconstruct, rehabilitate, improve, and
- 7 stock the fishponds; and expend moneys from the special land and
- 8 development fund. All revenues derived from any government-
- 9 owned Hawaiian fishpond shall be deposited in the fund.
- 10 (b) The board may lease government-owned Hawaiian
- 11 fishponds with legislative authorization as provided under
- 12 section 171-53(c); provided that in lieu of legislative
- 13 authorization, the board may lease [such] fishponds if:
- 14 (1) A public hearing is conducted on the proposed lease on
- the island where the fishpond is located;
