### A BILL FOR AN ACT

RELATING TO ACCESS TO EDUCATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that every year, there 2 are a number of students who attend the Leeward community 3 college Waianae Moku education center who are ineligible for 4 federal financial aid because they are unable to access their parents' tax information, which is necessary to file a Free 5 Application for Federal Student Aid. Under the requirements of 6 7 the Free Application for Federal Student Aid, students up to the age of twenty-four need to report the information in their 8 9 parents' tax records in order to apply for federal financial 10 assistance. 11 The legislature further finds that many of these students 12 who are twenty-four years old or younger report that their 13 parents are incarcerated or homeless or that they have no 14 communication with their parents for various other reasons. 15 a result, a significant number of these students are ineligible 16 for federal financial aid and are often forced to drop out of

college. These students can end up with an outstanding balance

- 1 on their student accounts, which prevents them from continuing
- 2 their education or causes them to take out loans, which often
- 3 wind up in the collections process. Furthermore, being in
- 4 arrears regarding tuition poses a barrier to these students'
- 5 eligibility for financial aid in the future.
- 6 Therefore, the purpose of this Act is to appropriate funds
- 7 to Leeward community college Waianae Moku to support and assist
- 8 students who are twenty-four years old or younger and ineligible
- 9 to apply for federal financial assistance through the Free
- 10 Application for Federal Student Aid application because they are
- 11 unable to access their parents' tax information.
- 12 SECTION 2. (a) Leeward community college Waianae Moku
- 13 shall establish a program to support and assist students who are
- 14 twenty-four years old or younger and ineligible to apply for
- 15 federal financial assistance through the Free Application for
- 16 Federal Student Aid application because they are unable to
- 17 access their parents' tax information.
- 18 (b) To the extent practicable, Leeward community college
- 19 Waianae Moku shall model the program established in subsection
- 20 (a) after the McKinney-Vento Homeless Assistance Act, 42 United
- 21 States Code sections 11431, et seq.

- 1 (c) No later than twenty days prior to the convening of
- 2 the regular session of 2025, Leeward community college Waianae
- 3 Moku shall submit a report to the legislature concerning the
- 4 program established in subsection (a), including:
- 5 (1) The number of students supported and assisted; and
- 6 (2) The amount of financial aid received by each student;
- 7 provided that no personally identifiable information
- 8 shall be included.
- 9 SECTION 3. There is appropriated out of the general
- 10 revenues of the State of Hawaii the sum of \$ or so
- 11 much thereof as may be necessary for fiscal year 2024-2025 for
- 12 Leeward community college Waianae Moku to support and assist
- 13 students who are ineligible to apply for federal financial
- 14 assistance through the Free Application for Federal Student Aid
- 15 application because they are unable to access their parents' tax
- 16 information.
- 17 The sum appropriated shall be expended by the university of
- 18 Hawaii for the purposes of this Act.
- 19 SECTION 4. In accordance with section 9 of article VII of
- 20 the Hawaii State Constitution and sections 37-91 and 37-93,
- 21 Hawaii Revised Statutes, the legislature has determined that the



appropriations contained in H.B. No. , will cause the state 1 general fund expenditure ceiling for fiscal year 2024-2025 to be 2 exceeded by \$ per cent. In addition, the 3 or 4 appropriation contained in this Act will cause the general fund expenditure ceiling for fiscal year 2024-2025 to be further 5 6 exceeded by \$ per cent. The combined total or 7 amount of general fund appropriations contained in only these 8 two Acts will cause the state general fund expenditure ceiling 9 for fiscal year 2024-2025 to be exceeded by **10** per cent. The reasons for exceeding the or 11 general fund expenditure ceiling are that: 12 The appropriation made in this Act is necessary to (1)serve the public interest; and 13 14 (2) The appropriation made in this Act meets the needs 15 addressed by this Act. SECTION 5. This Act shall take effect upon its approval; **16** . provided that section 3 of this Act shall take effect on July 1, 17
