A BILL FOR AN ACT

RELATING TO AGRICULTURAL LAND USE POTENTIAL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the State needs to
- 2 become self-sufficient in growing its own food, as eighty-five
- 3 to ninety per cent of the State's food is imported.
- 4 The legislature further finds that forty-two per cent of
- 5 the State's agricultural land is currently unfarmed and that the
- 6 government is the largest landowner in the State, owning over
- 7 1,600,000 acres out of the 4,100,000 acres of total land in the
- 8 State.
- 9 Accordingly, the purpose of this Act is to:
- 10 (1) Require the department of agriculture to contract a
- third-party entity to compile a report evaluating the
- 12 agricultural land use potential of each parcel of
- 13 state-owned lands greater than five acres, excluding
- 14 commercial, residential, and department of education
- 15 lands; and
- 16 (2) Appropriate funds for the report.

The department of agriculture shall submit the report 15 of its findings and recommendations, including any proposed 16 **17** legislation, to the legislature no later than twenty days prior 18 to the convening of the regular session of 2025. In accordance with section 9 of article VII of 19 SECTION 3. 20 the Hawaii State Constitution and sections 37-91 and 37-93, 21 Hawaii Revised Statutes, the legislature has determined that the

- 1 appropriations contained in Act 164, Regular Session of 2023,
- 2 and this Act will cause the state general fund expenditure
- 3 ceiling for fiscal year 2024-2025 to be exceeded by
- 4 \$ or per cent. This current declaration takes
- 5 into account general fund appropriations authorized for fiscal
- 6 year 2024-2025 in Act 164, Regular Session of 2023, and this Act
- 7 only. The reasons for exceeding the general fund expenditure
- 8 ceiling are that:
- 9 (1) The appropriation made in this Act is necessary to
- serve the public interest; and
- 11 (2) The appropriation made in this Act meets the needs
- 12 addressed by this Act.
- 13 SECTION 4. There is appropriated out of the general
- 14 revenues of the State of Hawaii the sum of \$ or so
- 15 much thereof as may be necessary for fiscal year 2024-2025 for
- 16 the purposes of this Act.
- 17 The sum appropriated shall be expended by the department of
- 18 agriculture for the purposes of this Act.
- 19 SECTION 5. This Act shall take effect on July 1, 2024.
