BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

PART I

2 SECTION 1. In accordance with section 9 of article VII, of 3 the Constitution of the State of Hawaii and sections 37-91 and 4 37-93, Hawaii Revised Statutes, the legislature has determined 5 that the appropriations contained in this Act will cause the 6 state general fund expenditure ceiling for fiscal year 2024-2025 7 to be exceeded by \$, or per cent. The reasons 8 for exceeding the general fund expenditure ceiling are that the 9 appropriations made in this Act are necessary to serve the 10 public interest and to meet the needs provided for by this Act. 11 SECTION 2. There is appropriated from the general revenues 12 of the State of Hawaii to the senate, house of representatives, 13 and legislative agencies indicated below, the following sums or 14 so much thereof as may be necessary for fiscal year 2024-2025, 15 to fund Hawaii employer-union health benefits trust fund costs
