### A BILL FOR AN ACT

PROPOSING AN AMENDMENT TO ARTICLE III, SECTION 12 OF THE HAWAII CONSTITUTION TO REQUIRE THE CHAIR OF A COMMITTEE OF THE LEGISLATURE TO SET FOR PUBLIC HEARING EVERY BILL ASSIGNED TO THE COMMITTEE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Article III, section 12, of the Constitution of
 the State of Hawaii is amended to read as follows:

3

#### "ORGANIZATION; DISCIPLINE; RULES; PROCEDURE

4 **Section 12.** Each house shall be the judge of the 5 elections, returns and qualifications of its own members and 6 shall have, for misconduct, disorderly behavior or neglect of 7 duty of any member, power to punish such member by censure or, 8 upon a two-thirds vote of all the members to which such house is 9 entitled, by suspension or expulsion of such member. Each house 10 shall choose its own officers, determine the rules of its 11 proceedings and keep a journal. The ayes and noes of the 12 members on any question shall, at the desire of one-fifth of the 13 members present, be entered upon the journal.

14 Twenty days after a bill has been referred to a committee
15 in either house, the bill may be recalled from such committee by

the affirmative vote of one-third of the members to which such
 house is entitled.

3 The chair of a committee shall set for public hearing every
4 bill assigned to the committee.

5 Every meeting of a committee in either house or of a 6 committee comprised of a member or members from both houses held 7 for the purpose of making decision on matters referred to the 8 committee shall be open to the public.

9 By rule of its proceedings, applicable to both houses, each 10 house shall provide for the date by which all bills to be 11 considered in a regular session shall be introduced."

SECTION 2. The question to be printed on the ballot shallbe as follows:

14 "Shall the Constitution of the State of Hawaii be amended 15 to require the chair of a committee to set for public 16 hearing every bill assigned to the committee?"

17 SECTION 3. New constitutional material is underscored.
