### A BILL FOR AN ACT

RELATING TO HEALTH.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Alzheimer's disease
- 2 is a large and growing epidemic that has a huge impact in
- 3 Hawaii. More than six million Americans are currently living
- 4 with Alzheimer's disease, a figure expected to reach 12.7
- 5 million in 2050. In 2019, Alzheimer's disease was the sixth
- 6 leading cause of death in the United States, with deaths from
- 7 the disease having risen by one hundred forty-five per cent
- 8 between 2000 and 2019.
- 9 The legislature further finds that in 2020, family members
- 10 and friends of individuals living with Alzheimer's disease and
- 11 other forms of dementia provided 15.3 billion hours of care at
- 12 an economic value of nearly \$244,000,000,000. More than forty
- 13 per cent of seniors in assisted living facilities have
- 14 Alzheimer's disease.
- 15 The legislature additionally finds that one-third of
- 16 recipients of home health care and adult day care have
- 17 Alzheimer's disease. The average per-person medicaid spending

- 1 for seniors with Alzheimer's disease and other forms of dementia
- 2 is twenty-three times greater than the average per-person
- 3 medicaid spending across all seniors without dementia. In
- 4 total, caring for people with Alzheimer's disease generated an
- 5 estimated medicaid cost of \$59,000,000,000 in 2021. Between
- 6 2020 and 2025, thirty states will see medicaid spending on
- 7 people with Alzheimer's disease increase by at least twenty per
- $oldsymbol{8}$  cent, before adjusting for inflation. By 2050, medicaid
- 9 spending on those with Alzheimer's disease will total an
- 10 estimated \$199,000,000,000, based on current dollars.
- 11 The purpose of this Act is to establish and appropriate
- 12 funds for a working group to plan and implement a public health
- 13 campaign for Alzheimer's awareness.
- 14 SECTION 2. (a) There is established the Alzheimer's
- 15 working group within the department of health for administrative
- 16 purposes. The working group shall plan and implement a public
- 17 health campaign for awareness of Alzheimer's disease and other
- 18 related dementia.
- 19 (b) The Alzheimer's working group shall be comprised of
- 20 the following members:
- 21 (1) The director of health, or the director's designee;

- 7 (c) In planning for the public health campaign for
- 8 Alzheimer's awareness and other related dementia, the
- 9 Alzheimer's working group shall include material to educate the
- 10 public on:
- 11 (1) The early signs of cognitive impairment;
- 12 (2) The value of early detection and diagnosis; and
- 13 (3) Discussing with health care professionals any changes
- in memory and thinking.
- 15 (d) The Alzheimer's working group shall submit a report of
- 16 its findings and recommendations, including any proposed
- 17 legislation, to the legislature no later than January 1, 2024.
- 18 The report shall include a media campaign with deliverables from
- 19 member organizations of the working group, a proposed budget for
- 20 each deliverable, and a proposed timeline to execute the planned
- 21 activities of the media campaign.

- 1 (e) The Alzheimer's working group shall dissolve on
- 2 December 31, 2025.
- 3 SECTION 3. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$1,000,000 or so much
- 5 thereof as may be necessary for fiscal year 2023-2024 for the
- 6 purposes of the Alzheimer's working group established by this
- 7 Act.
- 8 The sum appropriated shall be expended by the department of
- 9 health for the purposes of this Act.
- 10 SECTION 4. This Act shall take effect on July 1, 2023.
