

### A BILL FOR AN ACT

RELATING TO SPECIAL NUMBER PLATES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. 1 The legislature finds that every four years,
- 2 the world's greatest athletes convene at the Olympics for the
- ultimate trial of strength, endurance, and skill. Surfing, 3
- 4 known as the "sport of kings", a time-honored pastime, revered
- cultural practice, and one of Hawaii's most iconic exports, 5
- 6 debuted as an Olympic sport at the Tokyo 2020 Summer Olympics.
- During the Olympic surfing competition in challenging conditions 7
- 8 off Tsurigasaki beach, Carissa Kainani Moore ably represented
- Hawaii with grace and power to become the first female gold 9
- 10 medalist in Olympic surfing history.
- 11 The legislature further finds that Carissa Kainani Moore
- 12 should be recognized for her contributions as the world's first
- 13 Olympic gold medalist in surfing, a multi-year women's surfing
- 14 champion, and an advocate for numerous charitable causes,
- including her support of local surf clubs, gender equity, and 15
- 16 awareness of eating disorders. She was inducted into the
- Surfers' Hall of Fame in 2014. It is therefore appropriate that 17



- 1 Carissa Kainani Moore be honored with a special license plate to
- 2 further promote her legacy of gender equity in sports and in all
- 3 sectors.
- 4 Accordingly, the purpose of this Act is to authorize the
- 5 issuance of special number plates to recognize and honor Carissa
- 6 Kainani Moore.
- 7 SECTION 2. Chapter 249, Hawaii Revised Statutes, is
- 8 amended by adding a new section to be appropriately designated
- 9 and to read as follows:
- 10 "§249- Special number plates for Carissa Kainani Moore
- 11 authorized. (a) Notwithstanding any law to the contrary, the
- 12 director of finance shall issue to any registered owner of a
- 13 motor vehicle, who is a resident of the State, upon completed
- 14 application and payment of required fees, a special number plate
- 15 for the registered owner's motor vehicle commemorating Carissa
- 16 Kainani Moore, to observe her contribution to Hawaii.
- 17 (b) The director of finance of the city and county of
- 18 Honolulu, in consultation with the directors of finance of the
- 19 counties of Kauai, Maui, and Hawaii; the chiefs of police of the
- 20 city and county of Honolulu and the counties of Kauai, Maui, and

1	<u>Hawaii; a</u>	nd the executive director of Moore Aloha Charitable
2	Foundatio	n shall establish a special number plate design that:
3	(1)	Contains words, images, or both, that indicate the
4		special number plate is issued to recognize Carissa
5		Kainani Moore; provided that the director of finance
6		of the city and county of Honolulu may establish
7		special number plate designs to jointly or separately
8		recognize Carissa Kainani Moore;
9	(2)	Is similar in shape and size to the uniform state
10		number plate prescribed by law; and
11	(3)	Does not obstruct the visibility of the number or
12		letters or any other information that is required by
13		law to be on a number plate and is readily
14		identifiable and distinguishable under actual traffic
15		conditions.
16	(c)	The special number plate design shall not:
17	(1)	Infringe upon or otherwise violate any trademark,
18		trade name, service mark, copyright, or other
19		proprietary or property right;
20	(2)	Represent any obscene or degrading image, idea, word,
21		or phrase;

1	(3)	Advertise of endorse a product, brand, of service that
2		is provided for sale;
3	(4)	Promote any religious belief; or
4	(5)	Promote any philosophy based on prejudice or that is
5		contrary to state civil rights laws.
6	<u>(d)</u>	Each special number plate shall be securely fastened
7	to the mo	tor vehicle in lieu of the uniform state number plate.
8	<u>(e)</u>	The director of finance shall charge a special number
9	plate fee	at least equal to the county's cost of providing the
10	special n	umber plate and administrative costs, if any, plus a
11	fundraisi	ng fee to be determined by the director of finance in
12	consultat	ion with the executive director of Moore Aloha
13	Charitable	e Foundation. The fundraising fee shall be in addition
14	to any ot	her state or county fees collected for a motor vehicle
15	registrat	ion or license plate.
16	(f)	The director of finance may charge an additional
17	fundraisi	ng fee, of the same or a different amount as the
18	fundraisi	ng fee established pursuant to subsection (e), for the
19	renewal o	f a special number plate. If an additional fundraising
20	fee is im	plemented pursuant to this subsection, the director of
21	finance s	hall not renew and instead shall revoke the special

- 1 number plate of the registered owner of a motor vehicle who
- 2 fails to pay the additional fundraising fee imposed by this
- 3 subsection.
- 4 (q) The revenue generated by the fundraising fees, or a
- 5 portion of the revenue generated by the fundraising fees as
- 6 determined by the director of finance, shall be deposited in the
- 7 name of Moore Aloha Charitable Foundation in a separate county
- 8 budget account. The director of finance shall determine the
- 9 most efficient means of directing the net revenue generated by
- 10 the fundraising fees to Moore Aloha Charitable Foundation, as
- 11 appropriate, to fund programs that promote gender equity across
- 12 the State while developing world class water athletes as a
- 13 tribute to and in the spirit of Carissa Kainani Moore.
- 14 (h) The director of finance may revoke all special number
- 15 plates issued pursuant to this section if the total number of
- 16 registered owners of motor vehicles who obtain the special
- 17 number plates is less than one hundred fifty within three years
- 18 of issuance of the first special number plate.
- 19 (i) Nothing in this section shall be construed to apply to
- 20 any plates issued pursuant to section 249-9.2.

1	(j) For the purposes of this section, unless a different
2	meaning appears from the context, "special number plate" means a
3	license plate that commemorates Carissa Kainani Moore."
4	SECTION 3. New statutory material is underscored.
5	SECTION 4. This Act shall take effect upon its approval.
