Description:

Includes as a factor for determining whether the issuance of a controlled substances registration is in the public interest the prevention of activities within an applicant's areas that are potentially injurious to the health, safety, and welfare of the public and neighborhood. Establishes a Substance Use Disorder Services Clinic Working Group to develop recommendations to balance the needs of persons receiving treatment for substance use disorders with the needs of public safety. Requires a report to the Legislature. Effective 6/30/2050. (SD1)
