### A BILL FOR AN ACT

RELATING TO THE FESTIVAL OF PACIFIC ARTS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the festival of
- 2 pacific arts has been held approximately every four years since
- 3 its founding in 1972, bringing together a delegation of at least
- 4 two thousand five hundred artists, performers, and cultural
- 5 practitioners from different nations in Oceania to preserve and
- 6 perpetuate the arts and cultures of their indigenous peoples.
- 7 Visitors from around the world attend the festival of pacific
- 8 arts to appreciate what the artists, performers, cultural
- 9 practitioners from twenty-seven Pacific island nations, and the
- 10 host country have to offer, thereby creating a global market for
- 11 art, ideas, and products.
- In 2016, Hawaii won its bid to host the thirteenth festival
- 13 of pacific arts. To support Hawaii's winning bid, the
- 14 legislature enacted Act 104, Session Laws of Hawaii 2017, which
- 15 established a temporary commission to host the thirteenth
- 16 festival of pacific arts. The legislature additionally enacted
- 17 Act 142, Session Laws of Hawaii 2018, which appropriated funds

- 1 to the department of business, economic development, and tourism
- 2 for the commission to plan the festival of pacific arts to be
- 3 held in Honolulu from June 11 to June 27, 2020. However, the
- 4 onset of the coronavirus disease 2019 (COVID-19) pandemic
- 5 cancelled the original festival scheduled for 2020. With the
- 6 world emerging from the COVID-19 pandemic, Hawaii is scheduled
- 7 to host the thirteenth festival of the pacific arts to be held
- 8 in Honolulu from June 6 to June 16, 2024.
- 9 Therefore, the purpose of this Act is to appropriate funds
- 10 to the department of business, economic development, and tourism
- 11 for the commission on the thirteenth festival of pacific arts to
- 12 plan for the festival of pacific arts.
- 13 SECTION 2. There is appropriated out of the general
- 14 revenues of the State of Hawaii the sum of \$ or so
- 15 much thereof as may be necessary for fiscal year 2023-2024 and
- 16 the same sum or so much thereof as may be necessary for fiscal
- 17 year 2024-2025 for commission to plan for the festival of
- 18 pacific arts to be held in Honolulu from June 6 to June 16,
- **19** 2024.

- The sums appropriated shall be expended by the department 1
- of business, economic development, and tourism for the purposes 2
- of this Act. 3
- SECTION 3. This Act shall take effect on July 1, 2023. 4
