There is appropriated out of the general 5 revenues of the State of Hawaii to the Oahu region -- Hawaii 6 health systems corporation (HTH 215) the sum of \$1,000,000 or so 7 much thereof as may be necessary for fiscal year 2023-2024 and 8 the same sum or so much thereof as may be necessary for fiscal 9 year 2024-2025 for the capital improvement project to construct 10 a transitional treatment and housing facility on the Leahi 11 hospital campus; provided that no funds shall be expended unless 12 matched on a dollar-for-dollar basis by funds from the city and 13 county of Honolulu. 14 The sums appropriated shall be expended by the Hawaii 15 health systems corporation for the purposes of this Act. 16 SECTION 5. The appropriation made for the capital 17 improvement project authorized by this Act shall not lapse at 18 the end of the fiscal biennium for which the appropriation is

made; provided that all moneys from the appropriation

unencumbered as of June 30, 2025, shall lapse as of that date.

Requires the Oahu Regional Health Care System and the Department of Defense to provide a joint progress report to the Legislature regarding construction of, and the hiring of an operator for, the Daniel K. Akaka State Veterans Home. Appropriates funds for the capital improvement project to construct a transitional treatment and housing facility on the Leahi Hospital campus. Effective 6/30/2050. (SD1)
