

A BILL FOR AN ACT

RELATING TO FEDERAL LANDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. (a) There is established within the department 2 of land and natural resources for administrative purposes a 3 Makua valley task force to prepare for the transition of the 4 management of the Makua military reservation from the United 5 States Army when General Lease No. S-3848 expires. 6 The Makua valley task force shall consist of the 7 chairperson of the board of land and natural resources, or the 8 chairperson's designee, and a member of the board of trustees of 9 the office of Hawaiian affairs, or the board's designee, who 10 shall invite the following persons to be members of the task 11 force: 12 (1) A representative of the legislature; 13 (2) A representative of families who were evicted from the 14 Makua valley reserve or whose lands in the Makua
