### A BILL FOR AN ACT

RELATING TO THE STATE HISTORIC PRESERVATION DIVISION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the department of land and natural resources' state historic preservation division 2 3 serves to protect and preserve historic properties significant to Hawaii's history through several program areas. 4 The 5 legislature further finds that under section 23-5, Hawaii 6 Revised Statutes, the auditor may examine and inspect all 7 accounts, books, records, files, papers, and documents and all 8 financial affairs of every department, office, agency, and 9 political subdivision.

10 The purpose of this Act is to require the auditor to 11 conduct a performance audit of all the programs within the state 12 historic preservation division of the department of land and 13 natural resources.

SECTION 2. The auditor shall conduct a performance audit of all the programs within the state historic preservation division of the department of land and natural resources. The audit shall include but not be limited to:
