A BILL FOR AN ACT

RELATING TO GENERAL EXCISE TAX EXEMPTIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that Hawaii has the 2 highest cost of living in the nation. The general excise tax is 3 levied on nearly every economic activity, which, due to the 4 highly regressive structure of the tax, disproportionately 5 affects low-income and middle-class families. This regressive 6 nature makes it difficult for some families to afford basic life 7 necessities, such as diapers. Diapers are a large expense for Hawaii families with small children and are essential to babies' 8 9 and toddlers' health as they each require about fifty diaper 10 changes per week, or roughly two hundred diaper changes per 11 month. However, according to the National Diaper Bank Network, 12 one in three families struggles to afford clean diapers for 13 their children.

Hawaii children who come from low-income families are atrisk to meet their diaper needs. According to the National Diaper Bank Facts on Hawaii, fifteen per cent of Hawaii families are recipients of supplemental nutrition assistance program

benefits with children under the age of five; twenty-three per 1 2 cent of Hawaii families are women, infants, and children program 3 benefit recipients with infant children; and thirty-eight per 4 cent of Hawaii families receive temporary assistance for needy 5 families benefits with at least one child under the age of 6 three. The maximum amount a family of one parent and two 7 children can receive in temporary assistance for needy families 8 benefits is \$610. It is estimated that thirteen per cent of 9 this maximum benefit goes toward diaper needs. Additionally, 10 thirty-one per cent of Hawaii families have births covered by 11 medicaid. This data shows that there is a significant number of 12 families who are at risk of not having enough financial 13 resources to provide necessities, such as diapers, for their 14 children.

15 The legislature further finds that many child care 16 facilities require parents to provide diapers for their 17 children. Families who do not have access to clean diapers 18 cannot access child care and often miss work, reducing their 19 monthly income. Hawaii currently has two National Diaper Bank 20 Network member diaper banks that provide diapers to families; 21 however, this does not meet the needs of all families who

struggle to provide clean diapers for their children. According
to the National Diaper Bank, Hawaii families spend an average
monthly cost of \$80 on diapers. According to the American
Academy of Pediatrics, families may spend up to \$1,000 during
the first year of a child's life, which does not include the
costs of diaper wipes, diaper creams, and other diapering items.

7 The legislature also finds that dirty diapers put healthy children at risk of various diseases due to parasites, bacteria, 8 9 and viruses linked to dirty diapers. Dirty diapers can cause 10 diaper rash or diaper dermatitis, including Candida, a type of 11 yeast infection, and Seborrhea, a type of infectious skin 12 condition caused when skin is exposed to moisture, friction, 13 urine, stool, or other skin irritants. Other germs found in 14 dirty diapers are salmonella, listeria, and norovirus, which can 15 cause a healthy child to quickly fall ill. Hepatitis A is the 16 most common viral infection found in dirty diapers, which can 17 lead to other hepatitis-related infections, according to the 18 American Academy of Pediatrics. The American Academy of 19 Pediatrics also notes that certain diaper dermatitis can lead to 20 bladder infections that can cause urinary tract infections, 21 which more commonly affect girls.

1	The legislature notes that there are several other states
2	that exempt diapers from sales or excise taxes, while Hawaii
3	does not. The legislature believes that Hawaii should follow
4	the lead of these states by exempting diaper products from the
5	general excise tax.
6	Accordingly, the purpose of this Act is to help alleviate
7	the general excise tax burden on local families and individuals
8	by establishing a general excise tax exemption for the gross
9	proceeds or income from the manufacture, production, packaging,
10	and sale of diapers in the State.
11	SECTION 2. Chapter 237, Hawaii Revised Statutes, is
12	amended by adding a new section to be appropriately designated
13	and to read as follows:
14	" <u>§237-</u> Exemption for diapers. (a) There shall be
15	exempted from, and excluded from the measure of, the taxes
16	imposed by this chapter all the gross proceeds or income arising
17	from the manufacture, production, packaging, and sale of diapers
18	within the State.
19	(b) As used in this section, "diaper" means an absorbent
