### A BILL FOR AN ACT

RELATING TO HEARING AIDS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 237-24.3, Hawaii Revised Statutes, is
 amended to read as follows:

3 "§237-24.3 Additional amounts not taxable. In addition to
4 the amounts not taxable under section 237-24, this chapter shall
5 not apply to:

- Amounts received from the loading, transportation, and 6 (1) unloading of agricultural commodities shipped for a 7 8 producer or produce dealer on one island of this State to a person, firm, or organization on another island 9 of this State. The terms "agricultural commodity", 10 "producer", and "produce dealer" shall be defined in 11 the same manner as they are defined in section 147-1; 12 13 provided that agricultural commodities need not have 14 been produced in the State;
- 15 (2) Amounts received by the manager, submanager, or board16 of directors of:

17		(B)	Tugboat services including pilotage fees

2		officials to ships, barges, or vessels offshore;
3		rigging gear; checking freight and similar
4		services; standby charges; and use of moorings
5		and running mooring lines; and
6		(D) Wharfage and demurrage imposed under chapter 266
7		that is paid to the department of transportation;
8	(4)	Amounts received by an employee benefit plan by way of
9		contributions, dividends, interest, and other income;
10		and amounts received by a nonprofit organization or
11		office, as payments for costs and expenses incurred
12		for the administration of an employee benefit plan;
13		provided that this exemption shall not apply to any
14		gross rental income or gross rental proceeds received
15		after June 30, 1994, as income from investments in
16		real property in this State; and provided further that
17		gross rental income or gross rental proceeds from
18		investments in real property received by an employee
19		benefit plan after June 30, 1994, under written
20		contracts executed prior to July 1, 1994, shall not be
21		taxed until the contracts are renegotiated, renewed,



or extended, or until after December 31, 1998, 1 2 whichever is earlier. For the purposes of this paragraph, "employee benefit plan" means any plan as 3 defined in title 29 United States Code section 4 5 1002(3), as amended; Amounts received for purchases made with United States 6 (5) 7 Department of Agriculture food coupons under the 8 federal food stamp program, and amounts received for purchases made with United States Department of 9 Agriculture food vouchers under the Special 10 Supplemental Foods Program for Women, Infants and 11 12 Children; Amounts received by a hospital, infirmary, medical 13 (6) clinic, health care facility, pharmacy, or a 14 practitioner licensed to administer the drug to an 15 16 individual for selling prescription drugs, hearing aids, or prosthetic devices to an individual; provided 17 that this paragraph shall not apply to any amounts 18 received for services provided in selling prescription 19 drugs, hearing aids, or prosthetic devices. As used 20 21 in this paragraph:

1 "Prescription drugs" are those drugs defined under section 328-1 and dispensed by filling or 2 3 refilling a written or oral prescription by a practitioner licensed under law to administer the drug 4 and sold by a licensed pharmacist under section 328-16 5 or practitioners licensed to administer drugs; 6 7 provided that "prescription drugs" shall not include cannabis or manufactured cannabis products authorized 8 pursuant to chapters 329 and 329D; and 9

10 "Prosthetic device" means any artificial device or appliance, instrument, apparatus, or contrivance, 11 including their components, parts, accessories, and 12 replacements thereof, used to replace a missing or 13 14 surgically removed part of the human body, which is prescribed by a licensed practitioner of medicine, 15 osteopathy, or podiatry and that is sold by the 16 practitioner or that is dispensed and sold by a dealer 17 of prosthetic devices; provided that "prosthetic 18 device" shall not mean any auditory, ophthalmic, 19 20 dental, or ocular device or appliance, instrument, 21 apparatus, or contrivance;



Taxes on transient accommodations imposed by chapter 1 (7)237D and passed on and collected by operators holding 2 certificates of registration under that chapter; 3 Amounts received as dues by an unincorporated 4 (8) merchants association from its membership for 5 advertising media, promotional, and advertising costs 6 for the promotion of the association for the benefit 7 of its members as a whole and not for the benefit of 8 9 an individual member or group of members less than the entire membership; 10 Amounts received by a labor organization for real 11 (9) 12 property leased to: 13 A labor organization; or (A) A trust fund established by a labor organization 14 (B) for the benefit of its members, families, and 15 dependents for medical or hospital care, pensions 16 on retirement or death of employees, 17 apprenticeship and training, and other membership 18 service programs. 19 20 As used in this paragraph, "labor organization" means a labor organization exempt from federal income tax 21

under section 501(c)(5) of the Internal Revenue Code, 1 as amended; 2 Amounts received from foreign diplomats and consular 3 (10) officials who are holding cards issued or authorized 4 by the United States Department of State granting them 5 an exemption from state taxes; and 6 Amounts received as rent for the rental or leasing of 7 (11)aircraft or aircraft engines used by the lessees or 8 9 renters for interstate air transportation of passengers and goods. For purposes of this paragraph, 10 payments made pursuant to a lease shall be considered 11 rent regardless of whether the lease is an operating 12 lease or a financing lease. The definition of 13 "interstate air transportation" is the same as in 49 14 U.S.C. section 40102." 15 SECTION 2. New statutory material is underscored. 16 SECTION 3. This Act shall take effect on July 1, 2023. 17 18
