A BILL FOR AN ACT

RELATING TO THE HAWAII TECHNOLOGY DEVELOPMENT CORPORATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 206M-2, Hawaii Revised Statutes, is
- 2 amended by amending subsection (b) to read as follows:
- 3 "(b) The governing body of the development corporation
- 4 shall consist of a board of directors having nine voting
- 5 members. The director of business, economic development, and
- 6 tourism, [and an appointed member from the University of Hawaii,
- 7 or their designated representatives, or the director's
- 8 designee, and the chairperson of the board of regents of the
- 9 university of Hawaii shall serve as ex officio[+],[+] voting
- 10 members of the board[-]; provided that the chairperson of the
- 11 board of regents, with the approval of the board of regents and
- 12 subject to quorum and majority requirements, may designate
- another regent to serve. All members shall have knowledge,
- 14 interest, and proven expertise in, but not limited to, one or
- 15 more of the following fields: finance, commerce and trade,
- 16 corporate management, marketing, economics, engineering,
- 17 telecommunications, innovation, and other technology fields.



1	Seven of	the members shall be appointed by the governor pursuant	
2	to sectio	n 26-34 for staggered terms; provided that membership

- 3 All appointed members of the board shall continue in office
- 4 until their respective successors have been appointed. The

- 6 serve as the chairperson until such time as a chairperson is
- 7 elected by the board from the membership. The board shall elect
- 8 other officers as it deems necessary."
- 9 SECTION 2. Section 206M-15, Hawaii Revised Statutes, is
- 10 amended by amending subsection (b) to read as follows:
- 11 "(b) The development corporation may provide grants to any
- 12 business in Hawaii that:
- 13 (1) Receives a federal small business innovation research
- 14 phase I or II award or contract from any participating
- federal agency, up to fifty per cent of the amount of
- the federal award or contract;

17	State and	requires assistance for any of the following items:
18	(1)	Purchasing of manufacturing equipment;
19	(2)	Training of employees on the use of new or existing
20		manufacturing equipment;

Description:

Amends the composition of the Hawaii Technology Development Corporation Board of Directors to include the Chairperson of the Board of Regents of the University of Hawaii, unless the Chairperson, with the approval of the Board of Regents, designates another Regent to serve. Changes the cap for awards to assist businesses applying for the Small Business Innovation Research Grant Program and the Small Business Technology Transfer Grant Program of the Hawaii Technology Development Corporation to an unspecified amount. Adds purchasing of renewable energy systems as an eligible expense, and clarifies that training on both new and existing manufacturing equipment is an eligible expense, for the Manufacturing Development Grant Program of the Hawaii Technology Development Corporation.
