HOUSE CONCURRENT RESOLUTION

REQUESTING A TASK FORCE TO BE ESTABLISHED TO RECOMMEND CHANGES TO THE STRUCTURE AND ADMINISTRATION OF THE COMMISSION ON WATER RESOURCE MANAGEMENT TO IMPROVE ITS OPERATIONS AND FUNCTIONS AND PROTECT ITS MISSION.

1 WHEREAS, the Commission on Water Resource Management 2 administers the State Water Code, which was enacted in 1987; and 3 4 WHEREAS, water is a finite resource that must be carefully 5 managed and allocated in order for the State to meet its mandates; and 6 7 8 WHEREAS, article XII, section 7, of the Hawaii State 9 Constitution reaffirms and protects all rights customarily and traditionally exercised for subsistence, cultural, and religious 10

purposes and possessed by ahupua'a tenants who are descendants of native Hawaiians who inhabited the Hawaiian Islands prior to 1778, subject to the right of the State to regulate these 14 rights; and

15 WHEREAS, article XI, section 1, of the Hawaii State 16 Constitution states that for the benefit of present and future 17 generations, the State and its political subdivisions shall 18 19 conserve and protect Hawaii's natural beauty and all natural 20 resources, including land, water, air, minerals, and energy resources, and shall promote the development and utilization of 21 these resources in a manner consistent with their conservation 22 23 and in furtherance of the self-sufficiency of the State; and 24

WHEREAS, the State Water Code requires that adequate provisions be made for the protection of traditional and customary native Hawaiian rights; protection and propagation of fish and wildlife; maintenance of proper ecological balance and scenic beauty; and preservation and enhancement of the waters of



1 the State for municipal uses, public recreation, public water supply, agriculture, and navigation; and 2 3 4 WHEREAS, the Commission on Water Resource Management's 5 mission is to protect and manage the waters of the State for present and future generations; and 6 7 8 WHEREAS, the Commission on Water Resource Management is statutorily attached to the Department of Land and Natural 9 Resources; and 10 11 12 WHEREAS, because of this administrative structure, there 13 may be real or perceived conflicts of interest between the Commission on Water Resource Management and Department of Land 14 15 and Natural Resources; and 16 17 WHEREAS, the Commission on Water Resource Management faces certain political and legal vulnerabilities in implementing the 18 State Water Code that could allow external interests to unduly 19 impede its important work; and 20 21 22 WHEREAS, under existing law, the Chairperson of the 23 Commission on Water Resource Management is the Chairperson of 24 the Board of Land and Natural Resources, who serves as a member of the Governor's cabinet, and the Chief Legal Counsel of the 25 Commission on Water Resource Management is the Attorney General, 26 27 who also serves as a member of the Governor's cabinet; and 28 29 WHEREAS, as currently structured, the Chairperson of the 30 Board of Land and Natural Resources and Attorney General wield considerable influence over the Commission on Water Resource 31 Management and its staff, including the ability to determine 32 whether and how submittals containing recommendations for action 33 reach the Commission; and 34 35 WHEREAS, it was claimed in August 2023 that the Chairperson 36 37 of the Commission on Water Resource Management holds the unilateral authority to remove the Deputy Director for Water 38 Resource Management, without notice to or input by the public or 39 40 Commission; and 41

BE IT FURTHER RESOLVED that the Department of Land and 6 Natural Resources is requested to provide any necessary 7 administrative and staff support to the task force, including 8 9 the preparation of the report; and

11 BE IT FURTHER RESOLVED that certified copies of this Concurrent Resolution be transmitted to the Chief Justice of the 12 Hawaii Supreme Court, Chairperson of the Board of Trustees of 13 the Office of Hawaiian Affairs, Chairperson of the Board of Land 14 and Natural Resources, and Acting Deputy Director for Water 15 16 Resource Management.
