## HOUSE CONCURRENT RESOLUTION

REQUESTING THE STATE HEALTH PLANNING AND DEVELOPMENT AGENCY TO CONVENE A HEALTH INFORMATION DATA SHARING WORKING GROUP TO COLLABORATE AND ESTABLISH THE FRAMEWORK AND STANDARDS FOR FUTURE HEALTH INFORMATION DATA SHARING LEGISLATION.

1 WHEREAS, the ability to securely and efficiently share 2 patient health information electronically has become vitally 3 important to improve health outcomes, reduce health care costs, 4 and connect health care providers together to enhance care 5 coordination; and

7 WHEREAS, while there has been limited progress in linking 8 the State's health care entities, there is a great opportunity 9 to address health equity and positively impact Social 10 Determinants of Health through the sharing of real time health 11 information data; and

WHEREAS, while there are federal funding opportunities available to assist the development of health information data sharing, such as the States Advancing All-Payer Health Equity Approaches and Development Model, there is also a need to convene health care industry stakeholders to identify and evaluate federal funding programs to strengthen Hawaii's health care system; and

WHEREAS, Hawaii has the opportunity to shape state health information data sharing policies to ensure a prioritization of privacy and individual ownership of data while aligning with national standards and a common set of policies to improve the health outcomes of the State's residents; and

WHEREAS, the coronavirus disease 2019 pandemic and the Maui
wildfires in 2023 underscored the need for a flexible delivery
of health care that meets the needs of the State's most

1 vulnerable and often isolated residents through leveraging the power of interconnected technology for timely and accurate data 2 3 sharing to support emergency response efforts and public health interventions; and 4 5 6 WHEREAS, there is value in accelerating and expanding the types of health information shared among health care entities 7 and government agencies in Hawaii to improve health outcomes in 8 Hawaii's communities; now, therefore, 9 10 11 BE IT RESOLVED by the House of Representatives of the Thirty-second Legislature of the State of Hawaii, Regular 12 Session of 2024, the Senate concurring, that the State Health 13 Planning and Development Agency is requested to convene a Health 14 15 Information Data Sharing Working Group to collaborate and 16 establish the framework and standards for future health 17 information data sharing legislation; and 18 19 BE IT FURTHER RESOLVED that the working group is requested 20 to consist of the following members: 21 22 (1)The Administrator of the State Health Planning and Development Agency, or the Administrator's designee, 23 24 who is requested to serve as the chair of the working 25 group; 26 27 (2)The Director of Health, or the Director's designee; 28 The Chief Information Officer of the Office of 29 (3) 30 Enterprise Technology Services, or the Chief 31 Information Officer's designee; 32 (4) 33 The Administrator of the Med-QUEST Division of the 34 Department of Human Services, or the Administrator's 35 designee; 36 37 (5) The Insurance Commissioner, or the Insurance 38 Commissioner's designee; 39 40 (6) The Administrator of the Hawaii Employer-Union Health 41 Benefits Trust Fund, or the Administrator's designee; 42
