## HOUSE RESOLUTION

REQUESTING THE DEPARTMENT OF HEALTH TO CONVENE A STAKEHOLDER WORKING GROUP TO MAKE RECOMMENDATIONS TO ENHANCE MEANINGFUL ACCESS TO HEALTH CARE IN THE STATE THROUGH THE PROVISION OF LANGUAGE ASSISTANCE SERVICES.

1 WHEREAS, recognizing the importance of ensuring accessible, 2 affordable, and equitable health care for all individuals is in 3 the public interest; and 4 5 WHEREAS, Title VI of the Civil Rights Act of 1964 mandates recipients of federal financial assistance to take reasonable 6 steps to provide meaningful access to programs, services, and 7 8 activities for limited English proficient (LEP) persons; and 9 10 WHEREAS, the U.S. Census Bureau's 2021 American Community Survey reveals that 21.5 percent of people in the United States 11 communicate in a language other than English at home, with 8.2 12 percent of them having a limited ability to speak English very 13 14 well, meeting the definition of limited English proficiency; and 15 16 WHEREAS, in Hawaii, 25.9 percent of persons aged five years 17 and older speak a language other than English at home; and 18 19 WHEREAS, the coronavirus disease 2019 pandemic underscored the critical necessity of services in Asian American, Native 20 21 Hawaiian, and Pacific Islander languages, with communities having high numbers of LEP residents experiencing higher rates 22 23 of incidence and mortality; and 24 25 WHEREAS, the August 2023 Maui wildfires increased the need 26 for accessible health care services, particularly for LEP 27 individuals; and 28 29 WHEREAS, the language barriers faced by LEP individuals 30 contribute to decreased quality of care, poor clinical outcomes, and more extended hospital stays, emphasizing the need for 31 32 language assistance services; and

1 2 WHEREAS, LEP individuals and those who are deaf, hard of hearing, blind, or have low vision, may require assistance such 3 4 as interpreters, translated materials, or alternative formats for effective communication during health care interactions; and 5 6 7 WHEREAS, communication and language barriers are linked to disparities in patient-provider interactions, particularly 8 9 affecting racial and ethnic minorities and the twenty-four 10 million adults with limited English proficiency residing in the United States; and 11 12 WHEREAS, LEP individuals have shared experiences of having 13 to retain their own interpreters in health care settings even 14 15 after requesting their health care providers to arrange for professional interpreters; and 16 17 18 WHEREAS, studies indicate that access to communication and 19 language assistance is integral to the delivery of high-quality 20 health care for all populations; and 21 22 WHEREAS, Medicaid, Children's Health Insurance Program 23 providers, Medicare Part A providers, and organizations offering Medicare Advantage Plans and Prescription Drug Plans may need to 24 25 provide language assistance services to comply with federal 26 requirements; and 27 28 WHEREAS, while major hospitals across the State have made 29 strides in addressing language barriers, much remains to be done 30 to ensure comprehensive language access in health care settings 31 to guarantee equitable and effective communication for all 32 individuals, particularly those with limited English 33 proficiency; and 34 WHEREAS, effective communication is crucial in health care 35 36 and human services to prevent misdiagnosis, delayed medical 37 treatment, and barriers to necessary services and programs; now, 38 therefore, 39 40 BE IT RESOLVED by the House of Representatives of the Thirty-second Legislature of the State of Hawaii, Regular 41 Session of 2024, that the Department of Health is requested to 42

1 convene a Stakeholder Working Group to make recommendations to enhance meaningful access to health care in the State through 2 the provision of language assistance services; and 3 4 5 BE IT FURTHER RESOLVED that the Department of Health is requested to invite stakeholders, including health care 6 providers, insurers, representatives of community-based 7 organizations, language service providers, and the Healthcare 8 9 Association of Hawaii, to participate in the Stakeholder Working 10 Group; and 11 12 BE IT FURTHER RESOLVED that the Stakeholder Working Group 13 is requested to: 14 15 (1)Study and assess language access in health care settings across the State and on each island in the 16 State, including but not limited to: 17 18 19 (A) Experiences of LEP populations using language 20 assistance services; 21 22 (B) Existing language assistance services and 23 workforce; 24 25 (C) Disparities faced by LEP individuals in access to health care; 26 27 28 (D) Practice of using family members and friends as 29 interpreters in health care settings; 30 31 (E) Availability of interpreters; and 32 33 Requirements for providing interpretation (F) 34 services in medical and health care settings; and 35 36 (2) Make recommendations to enhance meaningful access to 37 health care in the State for individuals requiring 38 language assistance services; and 39 BE IT FURTHER RESOLVED that the Department of Health is **40** 41 requested to submit a report of the Stakeholder Working Group's 42 study, findings, and recommendations, including any proposed

legislation, to the Legislature no later than twenty days prior to the convening of the Regular Session of 2025; and BE IT FURTHER RESOLVED that a certified copy of this Resolution be transmitted to the Director of Health. 8 8
