## HOUSE RESOLUTION

REQUESTING THE DEPARTMENT OF HUMAN SERVICES TO ESTABLISH A WORKING GROUP TO ADDRESS ISSUES RELATING TO REIMBURSEMENTS AND PAYMENTS TO HOME AND COMMUNITY-BASED SERVICES PROVIDERS.

WHEREAS, home and community-based services providers carry 1 out essential and necessary services to the State's elderly and 2 vulnerable populations; and 3 4 WHEREAS, a 2022 study conducted by the actuarial firm 5 Milliman of reimbursement rates for home and community-based 6 services found that, for all provider types, current median 7 direct care wages paid by the service providers fell below the 8 United States Bureau of Labor Statistics twenty-fifth percentile 9 for those occupations; and 10 11 12 WHEREAS, adequate reimbursements and payments are crucial to sustain and improve the quality of care provided by home and 13 community-based residential care home facilities; and 14 15 WHEREAS, there is a pressing need to identify and implement 16 measure to enhance reimbursement rates for all home and 17 community-based services providers; now, therefore, 18 19 BE IT RESOLVED by the House of Representatives of the 20 Thirty-second Legislature of the State of Hawaii, Regular 21 Session of 2024, that the Department of Human Services is 22 requested to establish a working group to address issues 23 relating to reimbursements and payments to home and community-24 based services providers; and 25 26 27 BE IT FURTHER RESOLVED that the working group is requested to consist of the following members: 28 29
