HOUSE RESOLUTION

REQUESTING THE DEPARTMENT OF EDUCATION, IN COLLABORATION WITH THE DEPARTMENT OF LAW ENFORCEMENT, TO CONDUCT A STUDY ON THE FEASIBILITY OF HAVING SCHOOL RESOURCE OFFICERS IN THE STATE AND THE EFFECTS OF HAVING SCHOOL RESOURCE OFFICERS ON THE CAMPUSES OF EDUCATIONAL INSTITUTIONS.

1 WHEREAS, public schools in the State have been marred by a series of disturbing incidents that have jeopardized the safety 2 and well-being of our children and educators; and 3 4 5 WHEREAS, in November 2022, Waikoloa Elementary and Intermediate School was placed on lockdown due to an armed 6 individual on campus; and 7 8 WHEREAS, in October 2023, Waianae High School and Castle 9 High School were forced to cancel a football game due to 10 credible gun threats; and 11 12 13 WHEREAS, in December 2023, Nanakuli High School reported an afterhours armed robbery; and 14 15 WHEREAS, in January 2024, Waimanalo Elementary and 16 Intermediate School went on lockdown due to a report about an 17 18 armed individual on campus; and 19 WHEREAS, these incidents are not isolated events but 20 21 represent a growing trend of violence and disruption within the State's public schools; and 22 23 WHEREAS, such threats undermine the very foundation of 24 education, creating an atmosphere of fear and anxiety that 25 26 impedes learning and jeopardizes the future of Hawaii's children; and 27 28

WHEREAS, the use of school resource officers in the State 1 deserves consideration to ensure the protection of young 2 3 children in Hawaii; now, therefore, 4 5 BE IT RESOLVED by the House of Representatives of the Thirty-second Legislature of the State of Hawaii, Regular 6 7 Session of 2024, that the Department of Education, in collaboration with the Department of Law Enforcement, is 8 requested to conduct a study on the feasibility of having school 9 resource officers in the State and the effects of having school 10 11 resource officers on the campuses of educational institutions; 12 and 13 BE IT FURTHER RESOLVED that the Department of Education is 14 requested to submit a report of its findings and 15 16 recommendations, including any proposed legislation, to the Legislature no later than twenty days prior to the convening of 17 the Regular Session of 2025; and 18 19 20 BE IT FURTHER RESOLVED that certified copies of this Resolution be transmitted to the Chairperson of the Board of 21 Education, Superintendent of Education, and Director of Law 22 Enforcement. 23 24 25 OFFERED BY: Ce Qe 26
