A BILL FOR AN ACT

RELATING TO COMMUTING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the State's policy
- 2 of providing highly subsidized parking for state employees
- limits the employees' choices, does not reduce traffic 3
- 4 congestion or greenhouse gas emissions, and contradicts state
- 5 policies to encourage alternative modes of transportation.
- 6 According to the department of accounting and general services,
- 7 four thousand and seventy-six subsidized parking stalls are made
- available to state employees on O'ahu, not including stalls 8
- 9 located at the University of Hawai'i or the department of
- 10 education buildings. An additional two hundred forty-three are
- 11 made available on Hawai'i island, two hundred seventy-eight on
- 12 Maui, and one hundred fifty-one on Kaua'i.
- 13 The legislature further finds that for many years the State
- 14 has offered the limited option to employees to pay for monthly
- 15 parking privileges at the department of accounting and general
- 16 services controlled lot located at or near the employee's
- 17 workplace through pre-tax payroll deductions. In addition to

- 1 the savings for purchasing parking pre-tax, the parking
- 2 privileges are offered at a rate of approximately one-third of
- 3 the public rate. For example, employee parking rates in the
- 4 Honolulu downtown area range from twenty dollars to sixty
- 5 dollars per month prior to any pre-tax savings, which is a
- 6 fraction of the cost to park in a nearby private lot.
- 7 Comparatively, the cost of a monthly adult bus pass on O'ahu
- 8 is eighty dollars and the State does not provide a comparable
- 9 bus pass benefit to its employees nor offer to all employees the
- 10 ability to purchase a bus pass on a pre-tax basis. State
- 11 employees who travel to work by bicycle, foot, wheelchair or
- 12 other mobility aid, or private car-sharing also do not receive
- 13 any transportation benefit or support even though their
- 14 commuting modes reduce the number of cars driven in the State
- 15 and parked in state lots.
- 16 The legislature also finds that other jurisdictions, such
- 17 as Washington, D.C., have enacted transportation benefits equity
- 18 laws and policies. Various options such as offering an
- 19 equivalent transportation benefit that employees could select to
- 20 apply to the cost of their preferred mode of transportation
- 21 could be implemented.

The director of human resources development, in 10 consultation with the Hawai'i climate change mitigation and 11 adaptation commission, state energy office, and department of 12 accounting and general services shall develop and implement a 13 comprehensive commuting choice benefit program for all state 14 employees regardless of mode of transportation. The program 15 shall include walking, rolling using a wheelchair or other 16 mobility aid, car sharing, biking, and using public **17** transportation, and shall encourage the use of healthy, safe, 18 economically sound, and environmentally sustainable commuting 19 modes and discourage the use of single-occupant vehicle 20 commuting.

- 1 SECTION 3. The director of human resources development
- 2 shall submit a report on the progress made toward implementing
- 3 the program to the legislature no later than forty days prior to
- 4 the convening of the regular session of 2024.
- 5 SECTION 4. This Act shall take effect upon its approval.
